ORDER

WHEREAS population changes in Minnesota, as measured by the 2000 United States Census, necessitate the redrawing of congressional and legislative district boundaries in order to satisfy the constitutional requirement that every person's vote must be worth as much as another's. *See Whitcomb v. Chavis*, 403 U.S. 124, 141-42 (1971) (citing *Reynolds v. Sims*, 377 U.S. 533, 563 (1964)); and

WHEREAS the Chief Justice of the Minnesota Supreme Court has recognized that it is preferable for the legislature to redraw these district boundaries, but has appointed this panel to proceed on the merits of this lawsuit so that it may promptly release redistricting plans "only in the event a legislative redistricting plan is not enacted in a timely manner." *Zachman v. Kiffmeyer*, 629 N.W.2d 98 (Minn. Jul 12, 2001) (Order of the Chief Justice); and

WHEREAS redistricting will affect every Minnesota citizen in that it bears on the legislative and congressional representation of voters and nonvoters alike; and

WHEREAS judicial redistricting panels have in the past held hearings to give members of the public the opportunity to participate in the redistricting of their states. *See, e.g., Lawyer v. Dep't of Justice*, 521 U.S. 567, 572-73 (1997) (noting redistricting hearings held by U.S. District Court for the District of Florida); *Old Person v. Cooney*, 230 F.3d 1113, 1118 (9th Cir. 2000) (Montana); *E. Jefferson Coalition for Leadership & Dev. v. Parish of Jefferson*, 926 F.2d 487, 490 (5th Cir. 1991) (Louisiana); *Watson v. Comm'rs Court*, 616 F.2d 105, 107 (5th Cir. 1980) (Texas); *Wilson v. Eu*, 823 P.2d 545, 547-48 (Cal. 1992). Likewise, the Minnesota Supreme Court holds public hearings on issues of public concern from time to time, as do administrative law judges. *See, e.g., Order for Hearing Re: Open Hearings in Juvenile Protection Matters*, No. C2-95-1476 (Minn. Sept. 25, 2001); *In re Excess Surplus Status of Blue Cross & Blue Shield*, 624 N.W.2d 264, 272-73 (Minn. 2001); and

WHEREAS the panel's redistricting criteria encourages the preservation of communities of interest, which include, but are not limited to, "groups of Minnesota citizens with clearly recognizable similarities of social, geographic, political, cultural, ethnic, economic, or other interests." *Zachman v. Kiffmeyer*, No. C0-01-160, at 3, 5 (Special Redistricting Panel Dec. 11, 2001) (Order Stating Redistricting Principles and Requirements for Plan Submissions); and

WHEREAS the panel would like to gather information about Minnesota communities from Minnesota citizens and would like to give members of the public the opportunity to provide the panel with facts, opinions, or concerns that may inform the redistricting process.

NOW, THEREFORE, IT IS HEREBY ORDERED that city, county, and other local officials, representatives of local community groups, and all interested members of the public residing anywhere in the State of Minnesota, are invited to comment on how they prefer their communities to be viewed during redistricting. The hearings will take place as follows:
