## Dear Judge Eide:

We write on behalf of L. Londell McMillan in response to Comerica's June 28, 2017 letter objecting to the discharge of Mr. McMillan.

We were surprised to see Comerica's letter stating that the Court should not consider Mr. McMillan's discharge at the same time as Bremer Trust's, and even more surprised that Comerica stated that Mr. McMillan had not been discharged in the Court's March 27, 2017 order (filed on April 5, 2017). The Court's March 27 order states at paragraph 7: "Bremer Trust and its agents are hereby discharged from any and all liability associated with its Special Administration of the Estate." If the Court is going to revisit Bremer's discharge, then it should consider Mr. McMillan's discharge at the same time. To the extent the Court needs to carve out any issue from the discharges, such as the Jobu Presents commission or the proposed UMG contract rescission, that can be done along the lines we proposed in our June 23, 2017 letter to the Court.

Comerica's position on Mr. McMillan's discharge can be viewed as antagonistic and harmful to Mr. McMillan's reputation. Rather than asking the Court simply to ignore Mr. McMillan's discharge, previously ordered by the Court, the proper route for Comerica to address Mr. McMillan's discharge is to make objections to it in connection with the Court's consideration of Bremer Trust's.

We note that it would be difficult to consider Bremer Trust's discharge without also considering Mr. McMillan's since claims against Mr. McMillan involve issues in which Mr. McMillan relied

on Bremer Trust and its attorneys when Mr. McMillan was acting on behalf of the Estate. We simply do not see how a Court could consider claims against Mr. McMillan that would allegedly preclude his discharge without also considering in conjunction with those claims the roles of Bremer Trust and its attorneys.

For these reasons, we respectfully request that the Court decline Comerica's request that the Court not consider Mr. McMillan's discharge at this juncture.
