Attached as Exhibit 1 is a true and correct copy of a May 2, 2016, letter from my partner Joel Abrahamson to Ms. Ellis-Lamkins, stating in part "We have appointed Bremer the sole officer and director of each of the Decedent's entities so that Bremer has the authority to exclusively act on behalf of the Estate."
- 4. Attached as Exhibit 2 is a true and correct copy of an October 27, 2016, letter I sent Ms. Ellis-Lamkins' counsel, reiterating the statement in the May 2 letter.

- 2. Please provide copies of all contracts, whether maintained in hard copy or in electronic form, relating to the business interests of the Decedent or entities controlled by the Decedent;
- 3. Please provide copies of all service agreements (including employment agreements), whether maintained in hard copy or in electronic form, to which the Decedent or any entities controlled by the Decedent is a party;
- 4. Please provide all financial records (including payables and receivables), whether maintained in hard copy or in electronic form, relating to the business interests of the Decedent or entities controlled by the Decedent;
- 5. Please refrain from destroying or altering any of the documents referenced in item nos. 2-4 above;

Dear Ms. Fearson:

I write in response to your letter on behalf of Phaedra Ellis-Lamkins dated October 21, 2016.

Your letter states that Ms. Ellis-Lamkins' status and responsibilities with respect to certain entities related to Prince Rogers Nelson is unclear. That statement is incorrect. On May 2, 2016, after Mr. Nelson died and Bremer Trust was appointed as the Special Administrator of his Estate, our law firm e-mailed a letter to Ms. Ellis-Lamkins on behalf of Bremer Trust, which explained that Bremer Trust was appointed as "the sole officer and director of each of the Decedent's entities so that Bremer has the authority to exclusively act on behalf of the Estate." That letter is enclosed for reference. Accordingly, Ms. Ellis-Lamkins has not been an officer of any Prince-related entities since that time, and there is no basis for the production of documents requested identified in your letter.




