MEMORANDUM OF LAW IN SUPPORT
OF FRANK WHEATON AND JUSTIN
BRUNTJEN'S MOTION FOR
APPROVAL OF PAYMENT FROM THE
ESTATE FOR SERVICES THAT
BENEFITTED THE ESTATE AS A
WHOLE

INTRODUCTION

Frank Wheaton and Justin Bruntjen (Attorneys) have served as counsel of record for Alfred Jackson (Client) from the beginning of this proceeding and continue to do so. During that time, Attorneys have performed a substantial amount of work that benefitted the Estate of Prince Rogers Nelson ("Estate") as a whole. Pursuant to Minn. Stat. § 524.3-720, Attorneys hereby submit this memorandum in support of its Motion for Approval of Payment from the Estate for Services that Benefitted the Estate as a whole ("Motion").

FACTUAL BACKGROUND

In April 2016, Client retained Attorneys to represent his interests in the legal proceedings of his late brother's Estate. Client was named in the initial petition along with two of his half siblings as a maternal half sibling of the decedent. Three other persons were named as half siblings as well related to decedent through his father's side. Together these six individuals make up the Non-Excluded Heirs and as so are

interested parties. (April 26, 2016 Petition) Based on all the information available to Attorneys it appears as only a matter of time before these Non-Excluded Heirs will be determined as the legal heirs of the Estate.

Attorneys have served as counsel for Client for the past ten months of the estate administration and continue to do so. During this time, Attorneys have worked collaboratively with the Special Administrator and other counsel for the Non-Excluded Heirs on an abundant amount of Estate Administration. This work has benefitted the Estate as a whole and not the client individually.

Mr. Bruntjen is an attorney based in Minneapolis, Minnesota. He focuses his practice on Business Litigation and Trust and Estate Planning. He was also named a Rising Star in Minnesota in 2017 in Estate Law. Mr. Wheaton is an attorney based in Indianapolis, Indiana and Los Angeles, California. Mr. Wheaton's experience in Estate Planning, Business, and Entertainment Law has been crucial to the administration of the Estate. This combination of experience in these different practice areas has benefitted the Estate in immeasurable ways especially considering the lack of entertainment lawyers retained by the Non-Excluded Heirs and the need for such attorneys in a case such as this. The turnover in attorneys representing the Non-Excluded Heirs during these proceedings have, at times, been detrimental to the Estate proceedings in that is has significantly slowed the administration of this estate. Mr. Wheaton and Mr. Bruntjen have the longest tenure of all attorneys on this case and the only attorneys who have been retained since the beginning of these proceedings. As such, Attorneys have spent a great amount of time not only helping newly retained counsel get up to speed on the case but also acting to build and maintain relationships between Non-Excluded Heirs counsel, a very important aspect of this case considering the Court's desire that the Non-Excluded Heirs be as united as possible in their decision making. Attorneys have spent a significant amount of time informing and educating new parties and lawyers to the case about the issues involved as well as the importance of maintaining relationships between the Non-Excluded Heirs, the Special Administrator and The Court. In addition, Attorneys spent time meeting with individuals and groups of investors with the goal of helping the Non-Excluded Heirs to acquire some cash flow while administration of the Estate is still in process. Attorneys have at all times provided these services with the utmost professionalism and with the intent of benefitting all the Non-Excluded Heirs and not just our client.

Given the complexity of this estate and the incredible amount of estate administration work done during these first ten months, Attorneys invested a substantial amount of time on issues and undertakings that benefitted the Estate as a whole and all of its beneficiaries, as opposed to Alfred Jackson individually. True and accurate copies of invoices related the attorney's fees and costs for which Attorneys seek payment from the Estate as part of this Motion and are attached as Exhibit A and B to the Affidavit of Justin Bruntjen, which is being filed under seal. In sum, Attorneys seek a total payment from the Estate of

Examples of some of the types of services for which Attorneys seek reimbursement from the Estate, which benefitted the Estate as a whole as opposed to any individual beneficiary, include but is not limited to the following:

- 1. Advising for passage of a right of publicity statute by the Minnesota Legislature, and providing advice and counsel to interested parties on the import of such legislation;
- 2. Putting together a proposal for the official Prince Tribute. This included putting together a team of producers, lawyers, investors, consultants, and performers to be able to execute this proposal. Although the Estate decided to go in a different direction than the proposal from Attorneys, the proposal gave the Estate negotiating power and leverage that helped secure a seven-million-dollar guarantee from the selected tribute proposal.
- 3. Advising and counseling on asset preservation and revenue generating

opportunities available to the Estate, as well as methods for capitalizing on those opportunities, including measures and opportunities related to the Estate's music assets, Paisley Park and other Estate-owned real estate, the Tribute concert, and educational and philanthropic endeavors, among others;

- 4. Identifying appropriate advisors to the Estate and participating in a process to identify those advisors;
- 5. Meeting with asset managers and other potential financial professionals in order to assist the beneficiaries in choosing the right firm to assist them with their respective financial goals.
- 6. Managing and advising the Estate, its representatives and its advisors to ensure Estate assets were managed in the best interest of the Estate and all its beneficiaries;
- 7. Working to ensure the Estate's advisors were compensated fairly, commensurate with the value of their services, and attempting to negotiate an amicable resolution of disputes with certain advisors;
- 8. Helping the Non-Excluded Heirs receive income from consulting agreements with the tribute concert and the Paisley Park Museum.
- 9. Working to determine the rightful heirs of the Estate and an appropriate process for determining those heirs, including genetic testing where appropriate under the Minnesota Probate Code and the Parentage Act;
- 10. Advocating against the heirship claims of Brianna Nelson, V.N., and others attempting to establish legally unsupportable heirship claims, responding to heirship related discovery requests, and exploring options for resolving heirship related appellate issues as quickly and efficiently as possible;
- 11. Petitioning for the final determination of heirs;
- 12. Researching and educating interested parties on alternative options for paying or deferring payment of estate taxes under the Internal Revenue Code;
- 13. Analyzing asset valuation information in connection with estate tax returns for various entities and interests relevant to the Estate;
- 14. Coordinating public statements by the Non-Excluded Heirs on issues of general importance to the Estate, including the Tribute, family memorial services, the opening of the Paisley Park Museum, and other matters;
- 15. Analyzing and educating the right of media to access the Courtroom and Estate related information;

- 16. Researching and vetting various financial institutions for the role of personal representative, along with researching alternative personal representative arrangements that would provide the heirs of this Estate with an appropriate amount of input on estate administration issues. Advised and counseled in selecting a financial institution to handle the administration of the estate.
- 17. Vetted and negotiated with possible investors in order to help secure to the interested Non-Excluded Heirs in order for them to get some money prior to their adjudication.

Attorneys have taken a conservative approach because they are mindful of the fact that it can be difficult for the Court, to differentiate between the types of legal services that benefitted the Estate as a whole versus those that benefitted an individual beneficiary. For that reason, Attorneys are not seeking payment from the Estate for services that arguably may have benefitted Alfred individually, as opposed the Estate as a whole. For example, Attorneys are not seeking payment from the Estate for most of the time spent corresponding or meeting with Alfred individually, the only hours Attorneys are seeking payment for concerning meeting with Alfred are for times where the meetings involved subjects that were to benefit the Estate as a whole or all of the non-excluded heirs. Attorneys, in keeping with their conservative billing agenda, could have billed the Estate for hundreds of more hours but chose not to do so in order to assist the court in differentiating between hours spent benefiting the estate as whole compared to work done for the sole benefit of Alfred.

ARGUMENT

Minnesota law allows for the payment of attorney's fees from the Estate for services rendered on behalf of the Estate where "the services of an attorney for any interested person contribute to the benefit of the estate, as such, as distinguished from the personal benefit of such person." Minn. Stat. § 524.3-720. In such cases, the "attorney shall be paid such compensation from the estate as the court shall deem just and reasonable and commensurate with the benefit to

the estate from the recovery so made or from such services." *Id.*; *see also In re Estate of Van Den Boom*, 590 N.W.2d 350, 354 (Minn. Ct. App. 1999) ("Van Den Boom [a remainder beneficiary], as an interested person, acted for the benefit of the estate by keeping a major asset intact. His attorney is entitled to fees.").

The Court uses the following factors to determine whether attorneys' fees sought in a probate proceeding are just and reasonable:

- (1) the time and labor required;
- (2) the experience and knowledge of the attorney;
- (3) the complexity and novelty of problems involved;
- (4) the extent of the responsibilities assumed and the results obtained; and
- (5) the sufficiency of assets properly available to pay for the services.

Minn. Stat. § 525.515(b).

In its July 29, 2016 fee petition, the Special Administrator aptly recognized "the unique and extraordinary nature of this proceeding and legal work performed on behalf of the Estate. The scope and sophistication required to represent the Estate may be unlike any other estate administration proceeding in Minnesota's history." It would be hard for Attorneys to argue with the Special Administrator's claims concerning the extraordinary nature of this Estate. Besides just the complex legal issues involved, representation on this Estate has crossed multiple and different areas of legal practice including entertainment law, probate law, business law, tax law, and other legal arenas very rarely involved in Probate proceedings. Through Attorneys efforts over the past 10 months, the Estate has been administered with guidance from the Non-Excluded Heirs, acting upon the advice of competent counsel, which ultimately benefitted the Estate as a whole, rather than any individual ultimately determined to be an heir of the Estate.

Alfred Jackson did not uniquely or individually benefit from the services provided by

Attorneys that are at issue in this Motion, not only because those services benefitted the Estate as a whole, but also because Mr. Jackson has not yet been adjudicated as an heir. In fact, had a will or child of Prince been discovered over the past 10 months or if a will or child is discovered in the future, then Attorneys efforts will have only provided a benefit to the Estate.

Assuming Alfred is determined to be an heir, the effort and expertise Attorneys brought to this proceeding assisted the Court, the Special Administrator, the Estate, and all those ultimately determined to be its beneficiaries.

In view of the time expended, the responsibility assumed, the results achieved, the size and complexity of the Estate, the sheer numbers of individuals claiming to be heirs, and Attorneys good faith belief that its services benefited the Estate, Attorneys respectfully seek reimbursement from the Estate for its efforts.

CONCLUSION

For all the foregoing reasons, Attorneys respectfully request that the Court authorize and direct the Special Administrator to pay a total of to Attorneys from the Estate. This includes for entertainment fees, for non-entertainment fees, and in expenses incurred. The work done by Attorneys have significantly benefitted the Estate as a whole.






