UMG RECORDINGS, INC.'S JOINDER IN COMERICA BANK & TRUST, N.A.'S MOTION TO APPROVE RESCISSION OF EXCLUSIVE DISTRIBUTION AND LICENSE AGREEMENT

TO ALL PARTIES AND THEIR COUNSEL: Please take notice that UMG Recordings, Inc. ("UMG") hereby joins in the Personal Representative's Motion to Approve Rescission (the "Motion") of the Exclusive Distribution and License Agreement dated January 31, 2017 (the "UMG Agreement"), which is set for hearing in this Court on June 13, 2017.

As described in the Motion, Warner Bros. Records, Inc. ("WBR") claims that it in fact holds certain of the key rights purportedly conveyed to UMG by the Estate. This cloud on title makes it impossible for UMG to exercise the rights for which it bargained.
