Dear Judge Eide:

We write pursuant to the Court's April 19, 2018 Order. First, attached hereto as <u>Exhibit A</u> is the Cash Flow Analysis provided to the Heirs earlier today.

Second, we wanted to provide the Court an update of communications with the Heirs, their counsel, and advisors that have occurred related to the proposed **second second s** 

- On April 25, 2018, David Dunn met with Justice Gilbert, and Michael Lythcott, Gregg Walker, and Jason Epstein (whom the Personal Representative understands are advising, at a minimum, Omarr Baker and Alfred Jackson, and possibly Tyka Nelson, Sharon Nelson, Norrine Nelson, and John Nelson, at least on certain matters) at Shot Tower's offices in Baltimore, where the parties spent several hours discussing the economics of the **Exercise Several**, as well as a draft of the Cash Flow Analysis.
- Troy Carter met personally with Justin Bruntjen on April 25 (while Mr. Carter was in Minneapolis to provide expert testimony for the Estate in the Ian Boxill arbitration matter).
- Mr. Carter and Jason Boyarski held a telephone conference with Lee Hutton on April 27.
- Mr. Dunn and Mr. Boyarski held a follow-up telephone conference with Mr. Lythcott and Mr. Walker earlier today.

The Personal Representative has also received and responded to three sets of written questions from Mr. Lythcott, Mr. Bruntjen, and Sam Johnson. Copies of those responses are attached

In addition, Justice Gilbert has scheduled a mediation with the parties for May 10, the focus of which is to discuss communications and the involvement of the Heirs, including the potential appointment of a single representative of the Heirs to consult with the Personal Representative, and the Estate's entertainment advisor and entertainment counsel on future entertainment transactions. The representatives of the Estate have also spent significant time since April 18th discussing this concept with the Heirs, their advisors and their legal counsel.

Please let us know if we can provide the Court any additional information in connection with this matter.
