We are writing on behalf of the Personal Representative in response to recent filings and communications received by Amelia Wodehouse, a/k/a Christina Johnson.

Ms. Wodehouse submitted three complaints and a variety of other filings in the above-captioned matter between June and September 2021. This Court granted the Personal Representative's motion to dismiss those complaints on September 20, 2021.

Ms. Wodehouse has resumed filing various materials related to her allegations. For example, Ms. Wodehouse filed a "motion to answer notice of filing of order to dismiss," on October 8, 2021.
