On January 22, 2018, the Minnesota Court of Appeals issued an opinion affirming in part, reversing in part, and remanding the fee awards Judge Eide filed on April 5, 2017 and May 15, 2017. The Court of Appeals entered Judgment on March 16, 2018 and no party sought review by the Minnesota Supreme Court. Judge Eide issued an Order for Submissions Regarding Remanded Fee Order on January 25, 2018 (the "January 25 Order"). The January 25 Order states that by March 2, 2018 the parties shall submit any memoranda to assist the Court in supplementing its findings in connection with the decisions filed on April 5, 2017 and May 15, 2017 in response to the Minnesota Court of Appeals decision filed January 22, 2018.

On February 20, 2018, the parties agreed to mediate the fee issues in connection with the decisions filed on April 5, 2017 and May 15, 2017. In order to facilitate that mediation, the parties agreed to continue the date for parties to submit additional input to the Court until May 2, 2018.

The parties mediated the matter with the retired Justice James H. Gilbert of the Gilbert Mediation Center, Ltd. The parties did not reach an agreement but continued to negotiate the fee issue after completion of the mediation.

The parties wish to continue to negotiate the fee issue. To facilitate that negotiation, the parties agree that the date to submit additional input, if any, as required by the Court's January 25 Order shall be extended until July 2, 2018, subject to the Court's approval.

Based upon the above it is stipulated between and among the parties:

1. The date for submission by any party of any additional input as required by the Court's January 25 Order shall be July 2, 2018.
