order of this Court. The redacted information qualifies as confidential commercial information

under Minn. R. Civ. P. 26.03(g), and there is no historical right of access to the information

under the test articulated in Minneapolis Star & Tribune Co. v. Schumacher, 392 N.W.2d 197

(Minn. 1986).
