## STIPULATION TO AMEND SCHEDULING ORDER RELATING TO CLAIMS ASSERTED BY ROC NATION AND AFFILIATED ENTITIES

This Stipulation seeking to modify the deadlines for fact and expert discovery is entered into by and between Comerica Bank & Trust, N.A. in its capacity as Personal Representative of the Estate of Prince Rogers Nelson (the "<u>Personal Representative</u>"), and Petitioners Roc Nation LLC, Project Panther, Ltd., Aspiro AB and WiMP Music AS (collectively, "<u>Petitioners</u>"). The parties agree that good cause exists to modify the scheduling order to facilitate ongoing settlement discussions. The parties jointly request that the Court modify the Scheduling Order and the Order Granting Stipulation To Amend Scheduling Order Relating to Claims Asserted by Roc Nation and Affiliated Entities as follows:

 Petitioners will serve responses and objections to the Personal Representative's Requests for Admission on or before <u>December 1, 2017</u>.

2. All factual discovery shall be completed by <u>March 15, 2018</u>.

3. The parties shall make expert disclosures as follows:

a. The identity of any expert who may testify at trial regarding issues on which the party has the burden of persuasion must be disclosed on or before <u>March 15</u>, <u>2018</u>.

b. The initial expert written report completed in accordance with Minn. R. Civ. P. 26.01(b)(4)(A) must be served on or before <u>April 15, 2018</u>.

c. Written reports of rebuttal experts completed in accordance with Minn. R. Civ. P. 26.01(b)(4)(B) must be served on or before <u>May 15, 2018</u>.

4. All dispositive and non-dispositive motions shall be filed by <u>August 1, 2018</u>.

5. Except as modified herein, all other provisions of the Court's Scheduling Order

Relating to Claims Asserted by Roc Nation and Affiliated Entities filed May 1, 2017 and

amended on September 12, 2017 and October 12, 2017 shall remain in full force and effect.
