ORDER REGARDING PUBLIC ACCESS TO AND COPYING OF ADMITTED TRIAL EXHIBITS AND COURT TV LIVESTREAM

On March 1, 2018, the Fourth Judicial District issued a Bench Procedure/Policy relating

to Public Requests for Viewing and Obtaining Copies of Court Filed Exhibits (Court Exhibit

Policy).

The Court Exhibit Policy provides in pertinent part as follows:

- 1. Exhibits will be made available for viewing within a reasonable timeframe after they have been deposited with court administration at the conclusion of a trial. . . .
- 2. Arrangements to view or obtain copies of exhibits must be scheduled through District Court. All media requests must be referred to the Hennepin County District Court Public Affairs Communications Specialist.
- 4. No sealed exhibits will be available for viewing at any time without a court order specifically stating that the exhibits may be unsealed for purpose of viewing and/or copying.
- 6. A judicial order must be provided for any requests to video tape exhibits, take pictures of exhibits, or obtain copies of a recording (including video, DVD, and audio recordings). The order shall indicate that the Court

Administrator will refer the recording duplication out through an approved Hennepin County District Court duplication services vendor. Requesting parties are responsible for all costs.

"There is no statutory mandate to make judicial records accessible to the public," *State v. C.P.H.*, 707 N.W.2d 699, 705 (Minn. App. 2006), and Minnesota's statutes requiring public access to government data do not apply to the judiciary, Minn. Stat. § 13.90 subd. 2. Public access to judicial records is governed by and subject to the Rules of Public Access to Records of the Judicial Branch (State Public Access Rules) and the Fourth Judicial District's Court Exhibit Policy. There is no absolute right to public access to all judicial records because courts retain the inherent judicial power to control court records. *State v. C.A.*, 304 N.W.2d 353, 358 (Minn. 1981); *C.P.H.*, 707 N.W.2d at 704-05.<sup>1</sup> The State Public Access Rules provide that evidentiary exhibits from a hearing or trial shall not be remotely accessible, Rule 8 subd. 5(c), and also generally authorize a court to restrict access to certain evidence by court order, in appropriate circumstances. Rule 8, subd. 5(a). Finally, Rule 8, subd. 6 of the State Public Access Rules authorizes the Court Administrator to charge appropriate fees to those requesting copies.

<sup>1</sup> See also Nixon v. Warner Communications, 435 U.S. 589, 597-99 (1978):

It is clear that the courts of this country recognize a general right to inspect and copy public records and documents, including judicial records and documents. ... It is uncontested, however, that the right to inspect and copy judicial records is not absolute. Every court has supervisory power over its own records and files, and access has been denied where court files might have become a vehicle for improper purposes. ... The few cases that have recognized [a common law right of access to judicial records and documents] agree that the decision as to access is one best left to the sound discretion of the trial court, a discretion to be exercised in light of the relevant facts and circumstances of the particular case.

This matter was tried between March 9, 2021 (start of voir dire) and April 20, 2021 (return of jury verdicts). Mr. Chauvin was sentenced on June 25, 2021. The trial and the sentencing hearing were livestreamed by Court TV pursuant to prior orders of this Court. Mr. Chauvin filed a notice of appeal on September 23, 2021, and his conviction and sentence are presently pending appeal.

Mr. Chauvin's co-defendants, Tou Thao, 27-CR-20-12949, Thomas Lane, 27-CR-20-12951, and J. Alexander Kueng, 27-CR-20-12953, are currently awaiting trial before this Court on charges of aiding and abetting second-degree murder and second-degree manslaughter in connection with George Floyd's death on May 25, 2020, and are also scheduled to commence trial in the United States District Court for the District of Minnesota in St. Paul, Minnesota on January 20, 2022 on charges alleging violations of George Floyd's federal civil rights.

During the course of the trial, a total of 245 exhibits -- numbered JRY 001-013, 015-020, 024-029, 031, 033, 035-036, 038-045, 047-049, 052-075, 077-078, 081-096, 110-111, 119, 124, 126-127, 129-182, 184-198, 200, 203, 206-248, 254-255, 265-269, 273-279, 281-282, 284-285, 287, 290, 619-620, 812, 918, 1007-1008, 1018-1020, 1032, 1041, 1045-1048, 1051, 1053-1055, and 1058-1061 -- were received into evidence and considered by the jury during its deliberations. Those exhibits are summarized in the spreadsheet attached as Exhibit A and are referred to throughout the balance of this Order as the "Admitted Trial Exhibits."

Upon conclusion of the trial, Court TV delivered to the Court a hard drive containing the complete livestream of jury selection and the trial, which has been marked as Court Exhibit 30.

Based upon all the files, records, and proceedings herein,

## **IT IS HEREBY ORDERED:**

1. Upon the filing of this Order, the Hennepin County District Court Public Affairs Communications Specialist (Communications Specialist) and appropriate others within Hennepin County District Court Administration, working in conjunction with the Court's criminal administrative staff, all of whom collectively presently have custody of the Admitted Trial Exhibits as well as of Court Exhibit 30, shall allow members of the public and press access to and the opportunity to inspect and view the Admitted Trial Exhibits and the Court TV livestream, Court Exhibit 30.

2. Court Administration shall make copies -- or, at the discretion of Court Administration, may refer copying and recording duplication out through an approved Hennepin County District Court duplication services vendor -- of any of the Admitted Trial Exhibits and of Court Exhibit 30 requested by any member of the public or press and provide those copies to the requesting parties upon payment by the requesting party of the standard Hennepin County District Court copying charges for such exhibits. In addition, if requested by Court Administration for any party requesting a copy of the Court TV livestream, Court Exhibit 30, the requesting party shall also provide, at the requesting party's expense, a suitable hard drive to Court Administration upon which the Court TV livestream is to be copied/duplicated.

3. Pursuant to the Court Exhibit Policy, no member of the public or press may obtain copies of any of the audio-video exhibits included among the Admitted Trial Exhibits by taking pictures of them or by other technical means of videotaping or duplicating them while viewing and inspecting such exhibits pursuant to paragraph 1. Copies of any audio-video exhibits, including the Court TV livestream, may only be obtained by a requesting party

pursuant to paragraph 2 upon payment of the required fees.

4. The Court defers management of the details of the processes by which inspection and viewing of the Admitted Trial Exhibits will be conducted and copies provided to requesting parties to Court Administration. All requests to inspect/view any of the Admitted Trial Exhibits or the Court TV livestream (Court Exhibit 30) and/or to obtain copies of any of those exhibits in accordance with this Order shall be referred to the Communications Specialist, whose contact information is available on the public website established for this case, on which website this Order is also being posted.
