General, hereby gives NOTICE that on September 11, 2020 at 9:00 a.m., the State will move the

Court to impose deadlines for expert disclosures in the above-captioned cases, as set forth below.

MOTION

On June 30, 2020, the Court issued a scheduling order in the above-captioned matters, which does not specifically address expert disclosures. The discovery in this case is extensive, and the discovery process is ongoing. The State anticipates that both parties to each case may seek to present expert witnesses on multiple topics. The State has not yet received any Rule 9.02 disclosures from any defendant.

With respect to expert witnesses and potential defenses, the State requests the Court set the following additional deadlines for the State and all defendants:

- October 8, 2020—Notice of Defenses: Deadline for defendants to provide notice of defenses as required by Minn. R. Crim. P. 9.02, subd. 1(5);
- December 8, 2020—Initial Expert Disclosures: Deadline for prosecution and defense initial expert disclosures, to include names, CVs, and general subject matter of anticipated testimony;
- 3. January 8, 2021—Full Expert Disclosures: Deadline for prosecution and defense full expert disclosures, to include results or reports of "physical or mental examinations, scientific tests, experiments, or comparisons" that relate to the case, and/or written summaries of the subject matter of each expert's testimony, along with any findings, opinions, or conclusions each expert will give, the basis for them, and the experts' qualifications, as required by Minn. R. Crim. P. 9.01, subd. 1(4) and Minn. R. Crim. P. 9.02, subd. 1(2).
