DEFENDANT THOMAS LANE NOTICE OF INTENT TO OFFER CHARACTER EVIDENCE

Thomas Kiernan Lane,

Defendant.

The State in its Amended Notice of Intent to Offer Other Evidence agrees that it will be required to prove "certain states of mind and disprove a claim of reasonable force". The State's burden as to Thomas Lane is that Lane knew that Chauvin was committing a third degree felony assault and with criminal intent aided Chauvin in the assault knowing that the force used by Chauvin was unreasonable.

With respect to criminal intent, knowledge, and reasonable force, Thomas Lane intends, pursuant to Rules 404(a)(1), 405(b), and 406 of the Minnesota Rules of Evidence, to put his pertinent trait of character for peacefulness in evidence. Lane will offer a body worn camera (Exhibit A), along with a transcript (Exhibit B), of him on January 23, 2020 at 3:40 a.m. working as a trainee officer. The body worn camera will show the jury that on this date and time Thomas Lane was involved in an encounter with a homeless Black individual in a wheelchair. The gentleman, named Quinton, was alone in his motorized wheelchair with a dead battery. Lane proceeded to assist the man and ultimately walked, pushing the wheel chair, through a snow, ice, rain mixture in the January winter cold to the police precinct where the gentleman could rest

inside a warm building while his motorized wheelchair charged.

This specific instance of conduct of Lane's character will be strong circumstantial evidence that Lane did not with criminal intent assist in the murder of George Floyd.

About 20 minutes.

Speaker 3:

20 minutes?

Quentin:

Yeah. [inaudible 00:03:15] What bus I can jump on or something to get to this Harbor

Lights?

What was the question?

Thomas Lane: How to get to Harbor Lights by bus. I think the light rail gets you closest, right?

Quentin:

Okay. Light rail.

Speaker 3:

I don't think there's really any buses.

Thomas Lane: I'd say light rail to the twins.

Well, Harbor Lights, and then I got [Gill 00:04:25], I'm a client of Gill's.

Thomas Lane: Okay.

Quentin:

They want me to come to this Harbor Lights.

Thomas Lane: Yeah, because if that's... Sometimes, those batteries get blown out, and they don't...

Yeah, like you're saying, it doesn't hold a charge. [crosstalk 00:04:36] Yeah, go ahead.

Quentin:

I think that's what's going on. I think it's dying out on me.

Thomas Lane: I didn't realize this was the entrance. Whoops. Oh, whatever.

Quentin:

That's why they had me over there, but...

Thomas Lane: Oh, did they come out and say something?

Quentin:

Yeah. I tried to get in there and get something to eat. I thought they had a plugin. I was

going to plug in while I'm eating.

Thomas Lane: Yeah. Is there a way to put it in neutral so I can move you easier?

Quentin:

They said it's got a button on each motor that you push.

Thomas Lane: Okay.

Speaker 3: She's plugged in right now, so we'll give it a little bit to charge, all right?

Quentin: Huh?

Thomas Lane: I didn't realize it's the entrance to [crosstalk 00:05:20]

Speaker 3: No, I know. Oh, you need to plug it into that? So it is charged already?

good spot.

just put your jacket on.

Thomas Lane: Okay. In the front hall? Can you get in the front door though?

Thomas Lane: Yeah. [inaudible 00:11:21] Hey, did you code 4 us? Code 4? Oh, boy. There's some snow.

Quentin:

I appreciate everything you're doing for me.

Thomas Lane: Yeah, man. Don't worry about it.

Quentin:

I'm trying to get help, but nobody [inaudible 00:11:51]

Thomas Lane: What's that?

Quentin:

I said I was trying to get help, but wouldn't nobody say nothing to me.

Thomas Lane: Yeah, that's kind of messed up. Not going to lie. That ain't right.

Quentin:

Kept walking past me. [inaudible 00:12:04]

Thomas Lane: Well, the precinct is warm, so at least you got... It's not like you're charging outside

somewhere. You hang out there for a little bit.

Quentin:

Okay.

Thomas Lane: You know how to get to Harbor from there, right?

Quentin:

No, I don't.

Thomas Lane: Vending machine there, but yeah, there's no drinking fountain in the front.

Quentin:

Okay. Can I get something out of the machine? How much it cost?

Thomas Lane: I'm not sure. Everything's different, I think.

They got Mountain Dew there?
