## **1. Instructions to Applicant**

Minnesota Government Access ("MGA") provides electronic access to appropriate court records and documents for a government agency through log-in accounts for the individual agency users. MGA is an Internet browser-based application that requires no installation.

This Change Request Form is the be completed by the Agency Account Manager for a government agency, with an existing MGA account that provides both court records and documents, not by an individual user. It is intended to make updates to the list of individual users with MGA accounts within an agency. Do not use this form to request a new account. Complete this entire form. You may clearly print, type, or complete electronically.

**Tip:** To complete this form electronically: 1) save to your computer, 2) press Tab to fill out the form fields, 3) save and attach to email submission.

If you are requesting that a new, authorized user from your agency have an MGA log-in account, that user must register for an MGA user account before this request is submitted. No action is required from the agency to remove a user login account prior to submitting this form.
