Juvenile Delinquency/Juvenile Protection

Juvenile Protection, or Children in Need of Protection or Services (CHIPS), actions are court cases that involve the health, safety, and welfare of children. Children can be considered CHIPS because they are abused or neglected, truant, runaway, or otherwise need protection or services.

Juvenile Delinquency actions are court cases that allege felony, gross misdemeanor, misdemeanor, and petty misdemeanor offenses committed by a minor. Case category assignment to an offense level is based upon the highest charge on the case. A juvenile traffic offender is any child alleged to have committed a traffic offense, except children under the jurisdiction of adult court as provided in Minn. Stat. § 260B.225.
