Change of Location form in the Social Services Information System (SSIS)

Court hearings are used to review the status and determine the permanent placement of children who have been placed in out-of-home care, including foster care. To ensure the Court receives up-to-date information about the whereabouts of children in out-of-home care, and to ensure that foster parents receive notice of all court proceeding regarding children in their care, notices to the Court of a change in the location in which a child is in out-of-home care is vital.

The document template is available in SSIS and is accessible through the Chronology folder as a Document: Notice that Child was returned to the Care of the child's parent or legal custodian or Notice of Change of Foster Care Location.
