# Meeting Summary Tribal Court State Court (TCSC) Forum Thursday, December 5, 2019

#### **Table Discussions & Recap**



Each table met as a small group to discuss common challenges and successes experienced by state and tribal courts (as well as any issues they'd like to change) and then shared their reflections with the larger group. Their reflections included, among other things:

- Access to each other's electronic court records;
- Rule 25 and the interplay between state law and ICWA in general when it comes to timelines;
- Shared resources such as the creation of state specialty courts, like ICWA courts;
- History of TCSC Forum & Rule 10;
- Family centered models for legal issues as something state courts can learn from tribal courts;
- Community service with tribal elder for kids with Fetal Alcohol Spectrum Disorder (FASD);
- State court judges knowing to inquire about tribal court orders that may exist;
- ICWA training for state court judges who only do CHIPS/ICWA cases sporadically;
- ICWA resource (or "help line") card for state and tribal court judges indicating who to contact with ICWA questions (to include contacts at the State Court Administrator's Office, the Minnesota County Attorneys Association, tribes, etc.)
