#### Participants:

To participate in remote hearings, you must have access to a device with internet, a video camera, and speakers. You can participate from your phone or personal computer. Your meeting ID and password is located on your hearing notice. If you do not have a notice or have questions, please contact Court Administration at 651-266-1999 or <https://www.mncourts.gov/Find-Courts/District-Court-Contact.aspx>.

If you do not have access to technology, you can utilize equipment provided at one of the locations listed below.

#### Public Viewing:

In order to view a court hearing, you must have access to a device with internet and speakers. You can view hearings from your phone or personal computer. Please contact Court Administration at 651-266-1999 or <https://www.mncourts.gov/Find-Courts/District-Court-Contact.aspx> to obtain information regarding upcoming hearings and to obtain a meeting ID and password. For in-person hearings, viewing options will be provided at the court facility on a first come, first serve basis.
