Amicus Donald J. Trump for President 2024, Inc. (hereinafter “the Campaign”) joins the arguments stated in the Brief of Donald J. Trump, filed in this case today, and incorporates those arguments herein as its own.¹

Amicus initially sought to participate in this case as a party. The Campaign filed the response to the petition that the Court authorized President Trump to make, explaining that the Campaign would represent President Trump’s interests as a candidate, and requesting leave to intervene insofar as the Court deemed it necessary. (Resp., 9/27/23, at 3 n.1.) On October 13, the Court denied intervention and directed that the Campaign could instead participate in the case as *amicus curiae*.

In response to the Court’s order, President Trump has elected to appear and participate on his own behalf. The Campaign’s arguments are identical to those stated in President Trump’s brief filed today. It therefore joins and adopts those arguments as its own.
