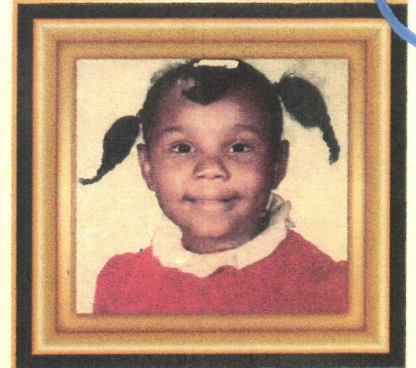


In reply to your letter or submission, received June 6, 2017, I regret to inform you that the Court is unable to assist you in the matter you present.

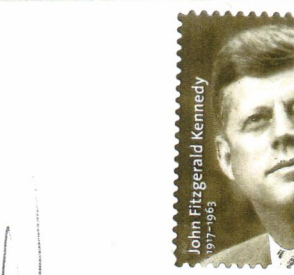
