**FINDINGS OF FACT,  
CONCLUSIONS OF LAW &  
ORDER RESTRICTING  
SUBMISSIONS**

---

The above-entitled matter came on before the Honorable Kevin W. Eide without a hearing after the Court's receipt of various submissions filed by Olando Enoex. Under prior Court orders and determinations by the Personal Representative pursuant to Court-approved or statutory procedures, any creditor claims and/or heirship claims by Mr. Enoex against the Estate of Prince Rogers Nelson have been disallowed and denied. Despite those denials, Mr. Enoex continues to file renewed requests.

Now, based on the file and proceedings herein, the Court makes the following:

**FINDINGS OF FACT**

1. The period for submitting creditor claims in this matter expired on September 12, 2016. *See* Minn. Stat. § 524.3-803(a).
2. On April 18, 2023, Olando Enoex filed a Written Statement of Claim alleging he is Prince Rogers Nelson, that he was "misreported deceased," and that the Estate is indebted to him in the amount of \$146,000,000.
3. On April 19, 2023, the Personal Representative provided Mr. Enoex with a Notice of Disallowance of Claim.
4. Despite the disallowance of his claims, Mr. Enoex filed additional documents with the Court on April 24 and 25, 2023. Those submissions include documents previously considered by the Personal Representative and/or the Court, including a Petition for Determination of Descent, another Written Statement of Claim, and Statements of Rights in Paternity Proceedings.
5. None of Mr. Enoex's numerous submissions provide any legal basis to establish a valid and enforceable creditor claim or heirship claim against the Estate.

6. Mr. Enoex's continuing submissions create unnecessary expense in the administration of the Estate in processing, reviewing, and responding to unsubstantiated claims.

### CONCLUSIONS OF LAW


1. Having been excluded as a claimant or heir of the Prince Rogers Nelson Estate, Mr. Enoex lacks standing to submit further claims, motions, or requests in this matter.

2. Mr. Enoex's continuing submissions are frivolous, and it is appropriate that the Court impose restrictions on his service or filing of any new claims, motions, or requests in order to protect the rights of the other parties and the Estate.

### ORDER

1. Future submissions by Mr. Enoex shall be deemed frivolous, need not be addressed by the parties, and shall not be addressed by the Court.
