INSTRUCTION GUIDE FOR "NOTICE OF ENTRY AND DOCKETING OF SUPPORT JUDGMENT AND AFFIDAVIT OF DEFAULT"

(For Arrearages of Child Support)

DOCUMENTS NEEDED

- 1. Notice of Entry and Docketing of Support Judgment and Affidavit of Default.
- 2. A copy of all the Court Orders for child support.

STEPS YOU MUST PERFORM

- 1. Completely fill out the form for Notice of Entry and Docketing of Support Judgment and Affidavit of Default. Fill in all of the blanks.
- 2. Sign the form before a Notary Public and have it notarized.
- 3. Make two copies, one for you, and one for the payor.
- 4. Attach a copy of the Court's order for child support to the payor's copy.
- 5. Mail the payor's copy to the address you have listed on the form as their mailing address.
- 6. Fill out the Verified Notice of Order and Affidavit of Service of Support Judgment and sign before a Notary Public.
- 7. Mail the Notice of Entry and Docketing of Support Judgment and the Verified Notice of Order and Affidavit of Service of Support Judgment to the court for processing.
