A child who is the subject of 3.5 a petition, and the parents, guardian, or legal custodian of the child have the right to 3.6 participate in all proceedings on a petition. Official tribal representatives have the right 3.7 to participate in any proceeding that is subject to the Indian Child Welfare Act of 1978, 3.8 United States Code, title 25, sections 1901 to 1963. 3.9

Any grandparent of the child has a right to participate in the proceedings to the 3.10 same extent as a parent, if the child has lived with the grandparent within the two years 3.11 preceding the filing of the petition.
