

## The Logo


The official logo consists of two primary parts; the “M” mark and the words MINNESOTA JUDICIAL BRANCH. In this, the preferred format, the composition is centered vertically. The internal size relationships should never be changed.

Alternate formats will be presented as you progress through this guide.




## Logo Presentation

Wherever the logo is used, every attempt should be made to insure that it is surrounded by a clear area equal to the height of the words "Judicial Branch" represented by the dimension "X".

## Colors

The official colors of the MINNESOTA JUDICIAL BRANCH logo are black and PMS 1245 gold.

There may be times when the official colors won't be available. In such cases it is recommended that the colors black and/or white be used. You will find examples at the end of this guide.

## Alternative Variations

Pictured at left are four acceptable variations of the logo in its vertical format. The two versions on the left would cover any two color application while the two to the right should be used when only the color black is available.

At the end of this guide you will find an alternate one color version for times when a white background is not available.

## Horizontal Format

There may be applications when the logo in its vertical format will not be suitable. In such cases it is recommended that this horizontal format be used. In order to maintain the size relationship between the “M” mark and the name, the type must be arranged in two lines as shown at left.

## Typeface

There may be instances when the official logo, seen here in its horizontal format, will require that additional wording such as OFFICES or JUDICIAL DISTRICTS be added. This additional wording should be set in uppercase Times New Roman Bold type, and should not exceed a height measuring two-thirds that of the JUDICIAL BRANCH.

## Horizontal Format Variations

Applications that require the logo to be combined with a STATE OFFICE or JUDICIAL DISTRICT should be arranged like the examples at left.

Note that in applications where additional wording such as a STATE OFFICE or JUDICIAL DISTRICT is not directly attached to the logo, the additional name may appear in any size or typeface desired.

## Examples of Application

These examples illustrate how the logo might be applied in both horizontal and vertical arrangements. The preferred two-color format was used with plenty of surrounding white background.

Note that the supplementary typeface is a sans serif such as Helvetica or Futura so as to differentiate and compliment the logo.

## Alternative Applications

Occasionally situations may arise when you must print one color on a colored or white background. In these instances it is recommended that black or white be used to maintain consistency without introducing additional colors into the logo.
