**STIPULATION TO STAY
PROCEEDINGS**

Petitioner Ricky Barron, a/k/a Rick Barron, d/b/a Barron Event Planning (“Petitioner”) and Comerica Bank & Trust, N.A. (“Comerica”), personal representative of Decedent’s estate (collectively, the “Parties”), jointly stipulate and move the Court for an Order staying any proceedings on Petitioner’s Petition in this matter pending the resolution of the civil action, captioned *Mixed Blood Theatre v. Paisley Park Enterprises, LLC, et al.*, Court File No. 10-CV-17-166, Carver Cnty. Dist. Ct. (the “Mixed Blood Lawsuit”).

WHEREAS, Petitioner filed its Petition for Allowance of Claim Previously Disallowed in this matter on or about January 10, 2017 (the “Petition”);

WHEREAS, Mixed Blood Theatre commenced the Mixed Blood Lawsuit on or about February 8, 2017, naming Petitioner and the Estate of Prince Rogers Nelson as co-defendants;

WHEREAS, the claims, facts and circumstances alleged in the Mixed Blood Lawsuit are the same as alleged in the Petition, the Parties have agreed to stay any proceedings on Petitioner’s Petition in this matter pending the resolution of the Mixed Blood Lawsuit;

IT IS THEREFORE STIPULATED AND AGREED that:

1. All proceedings on Petitioner’s Petition in this proceeding should be stayed for all purposes, without prejudice and without costs to any party, pending the resolution of the Mixed Blood Lawsuit.
