

**ADVISORY AND PARTICIPANT RIGHTS – CHIPS PERMANENCY**

**WHO IS A PARTY**

**WAA KUMA QOFKA DHINACA AH**

You are a party to this case pursuant to Rule 21 of the Rules of Juvenile Protection Procedure if you are one of the following:  
*Waxa aad ka tahay dhinac kiiskan sida uu qabo Xeerka 21 ee Xeerarka Habka Ilaalinta Dhallinyarada haddii aad tahay mid ka mida kuwaa soo socda:*

- The child’s parent, including any **parent** who is not a legal custodian and any parent who is an adjudicated or presumed father.
- *Waalidka canugga, oo uu ku jiro waalid kasta oo aan ahayn qofka sharciyan haya canugga iyo waalid kale oo loo xakumay ama loo haysto in uu yahay aabbaha.*
- In the case of an Indian child, the child’s Indian custodian or child’s Indian tribe.
- *Kiiska canugga Hindida, qofka haya canugga Hindida ama qabiilka canugga Hindida.*
- The person or social services agency who filed the petition.
- *Qofka ama hay’adda adeegyada bulshada xareysay codsiga.*
- The social services agency when someone else has filed a termination of parental rights or other permanency petition.
- *Hay’adda adeegyada bulshada marka uu qof kale xareeyay codsiga lagu soo gabagabaynayo xuquuqda waalidka ama codsiga kale ee joogtada.*
- The child’s guardian ad litem.
- *Ilaaliyaha canugga loo magacaabay.*
- A relative to whom the social services agency proposes to transfer the child’s permanent legal and physical custody.
- *Qofka qaraabada ah oo hay’adda adeegyada bulshada soo jeedisay in si joogto ah loogu wareejiyo haynta qofeed ee sharciga ee canugga.*
- Any person who intervenes as a party pursuant to Rule 23 or who is joined as a party pursuant to Rule 24.
- *Qof kasta oo soo dhexgala ka dhinac ahaan sida ku cad Xeerka 23 ama lagu soo biiriyay sida ku cad Xeerka 24.*
- Any other person who is determined by the court to be important to a resolution that is in the best interests of the child.
- *Qof kasta oo maxkamaddu go’aamisay in uu muhiim u yahay xalka ka tarjumaya danta canugga.*

**WHO IS A PARTICIPANT**

**WAA KUMA KA QAYBGALUHU**

You are a participant to this case pursuant to Rule 22 of the Rules of Juvenile Protection Procedure if you are one of the following:  
*Waxa aad tahay ka qaybgale kiiskan sida uu qabo Xeerka 22 ee Xeerarka Habka Ilaalinta Dhallinyarada haddii aad tahay mid ka mida kuwa soo socda:*

- The child who is the subject of petition.
- *Canugga ooah qofka uu codsiga quseeyo.*
- The child’s grandparent if the child has lived with you at any time during the two years before the filing of the petition.
- *Awoowaha/ayeeyada canugga haddii canuggu kula noolaa adiga waqti kasta oo ka mida inta lagu jray labadii sano ee codsigan la xareeyay ka hor.*
- The child’s relative or other person providing care for the child.
- *Qaraabada canugga ama qofka kale oo bixinaya daryeelka canugga.*
- The child’s foster parent or a person proposed as a long-term foster parent.
- *Waalidka canugga koriya ama qofka loo soo jeediyay in waqti dheer uu noqdo waalidka wax koriya.*
- The child’s spouse.
- *Sayga/xaaska canugga.*
- The guardian ad litem for the child’s legal custodian.
- *Ilaaliyaha loo magacaabay in uu noqdo qofka sharciyan canugga haya.*
- Any other person who is determined by the court to be important to a resolution that is in the best interests of the child.
- *Qof kasta oo kale oo maxkamaddu g’aamisay in uu muhiim u yahay xalka taaso ka tarjumaysa danta canugga.*

| X                       | X                                  | To be represented by an attorney. If you are the child, the child's parent, or the child's legal custodian, the Court may appoint an attorney to represent you if the Court determines that you qualify financially and that the appointment is appropriate. If you are the parent or Indian custodian of an Indian child, the court is required to appoint an attorney to represent you if you qualify financially. The Court cannot appoint an attorney to represent you if the only allegation is that the child is a truant, unless out-of-home placement is being considered by the court. The Court may order a parent or legal custodian to reimburse some or all of the attorney's fees.<br><i>In uu wakiil kaa noqdo qareen ku matala. | X                       | X                                  | If you are the child's foster parent, preadoptive parent, relative providing care for the child, or a relative to whom the social services agency proposes to transfer permanent legal and physical custody of the child, you have a right to offer information at each hearing. Any other person may request an opportunity to be heard, but the court is not required to grant your request.<br><i>Haddii aad tahay waalidka canugga korsada, waalid horay u korsaday, ama qaraabo bixiya daryeelka canugga, ama qaraabo ay hay'adda daryeelka bulshada ku talisay in si joogto ahaan loogu wareejiyo haynta qofka sharciga ee canugga, waxa aad xaq u leedahay in dhagaysi kasta aad ku bixisid machuumaad. |                         | X                                  | To automatically become a party to the case if you are the child who is the subject of this proceeding, or the child's parent, or the child's grandparent and the child has lived with you at any time during the two years prior to the filing of the petition in this matter. All other persons may ask the Court's permission to become a party to the case.
