1. I understand I am in Court because it is alleged I have intentionally violated the conditions of my probation or stayed sentence as set forth in the violation reports or other papers.
Ngang uwa weweiti pwe ngang uwa fiti/ika nomw non Kapung, pokiten non an ese mwo fat pwe ngang uwa pwisin finata ai upwe atai met ururun pungun ai we tipis, ika upwe chok sopweino ne aponuweta met ururun pungun ai we tipis uwa atai usun met a affat me non taropwe, ika pwan ekkoch taropwen pwarata.
2. I understand I have the following rights:
Ngang uwa weweiti pwe mei wor rei ekkei Pwuungun finata:
 - a. an attorney will be appointed to represent me if I cannot afford one;
epwewor emon Sou-Annuk epwe finnita an epwe tupuni ei ika anisi ei ika use tongeni pwisin moni emon nei.

- b. a hearing at which the state would be required to prove by clear and convincing evidence that I violated probation or failed to comply with a sentencing order;
eu arongorong mei affat pwe epwe kawor me ren ewe fonu/neni an epwe pwarata fiti pisekin pwarata mei pesei pungun pwe ngang uwa atai ewe fansoun ngang mei nom fan nemenien tipis ren ai upwe aponuweta met ururun pungung Kapung a finata;
- c. to have complete disclosure in advance of any evidence, including any written reports, to be used against me;
epwe akkomw kawor meinisin pisekin pwarata, epwe pachenog met mei mak non report, ekkei repwe tongeni pwarata met upwe tipis ren;
- d. to call and cross-examine any witnesses called to testify against me;
epwe kori emon epwe pwarata, ika emon aramas repwe kapas eis ngeni fan itei, an epwe pwarata met tipis ngang mei fori;
- e. to testify myself if I wish;
upwe tongeni pwisin pwarata porous fan itei ika ngang mei mochen;
- f. to offer evidence, subpoena witnesses and present arguments, describe circumstances or give an explanation;
epwe kawor pisekin pwarata, fan pochokkunen Annuk, mei tongeni awesieno an emon epwe pwarata ika awora ekkoch kapasen pwarata, epwe awewei ekkoch aninnisin porous ika awora tichchikin awewe;
- g. to appeal any decision made in my case.
epwe tongeni niwin ngeni Kapung an epwe tungor aweweochun popun pungun Kapung a fis non ai we case.

3. I wish to proceed as follows:

Uwa aneanei pwe upwe sopweino met upwe fori usun met mei affat me fan:

- a. waive (give up) my right to an attorney, admit the violations, and let the Court decide today whether or not to revoke my probation and execute the stayed portion my sentence. I understand I will be permitted to explain my situation to the judge.
upwe awesano/ataeno ai Pwuung ngeni nei Sou-Annuk, upwe fangeta ika pwarata pwe mei pung ai puratiw tipis, upwe mwut ngeni Kapung epwe finata ikenai ika/ika esap tongeni epwe ataeno met pungun ai we witiwit fan nemenien tipis, ika epwe tongeni fori pungun ai tipis. Uwa pwan weweiti pwe epwe tongeni mwut ngeni ei ai upwe awewei met tichchikin porousei ngeni ewe Sou-Kapung.
- b. request a continuance to hire my own attorney.

- c. request a court-appointed attorney and have completed a form showing my income, property and expenses.
tungor emon Sou-Annuk epwe kawor seni Kapung, epwe kawor echo taropwe epwe pwarata met money tonong rei, porousen fonuwei ika piseki, tori meinisin ai moni tou.
- d. deny that I violated my probation and request a hearing on another day. I give up my right to an attorney and will represent myself.
