# EXPEDITED CHILD SUPPORT PROCESS INSTRUCTIONS FOR REQUESTING A HEARING TO CONTEST SUPPORT JUDGMENT LEVY

## Who May Use This Form?

A party who has received notice that certain accounts at a financial institution have been frozen and wants the court to authorize release of these accounts back to the account holder may use this form to request a hearing.

### **How Do I Make A Motion and Request For A Hearing?**

- 1. Fill out the "Notice of Motion, Motion and Affidavit to Contest Support Judgment Levy" form (CSX1002) completely. Court personnel, the county attorney's office, and the child support office <u>cannot</u> help you fill out these forms.
- 2. The information to fill in the boxes and blanks at the top of the form can be found at the top of your current child support order or your divorce or paternity decree, including the county name, the court file number, and names of all the parties.
- 3. Copy the names of the parties in the exact same order as they appear on your current child support order or your divorce or paternity decree. If you are the Petitioner in the current order or decree you will be the Petitioner in this motion. If you are the Respondent in the current order or decree you will be the Respondent in this motion.
- 4. Fill in the name and address of the parties that will receive a copy of your request.
- 5. Skip over the next section that gives information about the hearing date, time, and location. **FILL THIS SECTION IN LAST.**
- 6. Under the section entitled "Motion," fill in the name of the financial institution where the frozen account is located. The notice you received from the county child support agency will explain that the account has been frozen to pay past due child support and/or spousal maintenance. Check the appropriate boxes (child support and/or maintenance) and to whom it is owed (county or obligee).
- 7. Under the section entitled "Affidavit," you must explain how there has been a mistake of fact or how the money seized is exempt from such a seizure. Check the appropriate box.
- 8. Contact court administration for a hearing date. Be sure to tell the clerk that you need a hearing date to contest a support judgment lien. A hearing must be scheduled within 10 days from the date of your request. Fill in the date, time, and location of the hearing.
- 9. Sign and date your request under penalty of perjury. Perjury is the crime of intentionally lying or misrepresenting the truth.
- 10. Make copies, serve, and file the motion.

#### Service

A copy of the completed "Motion to Contest Support Judgment Levy" form must be served on all parties, including the county attorney's office. You must arrange for someone else over the age of 18 who is not a party to this case to serve the papers for you:

- WHEN: No later than **2 business days** after you get the hearing date (a business day does not include a weekend or a legal holiday).
- HOW:
  - o *Serving the County Attorney's Office* Personal service (someone hand-delivers a copy of your motion to the county attorney's office), or service by fax.
  - o Serving the Other Party Personal service, service by fax, or service by mail.

The adult who serves the papers for you must fill out an *Affidavit of Service* form that shows who was served, how service was made, and when they were served. You can find an *Affidavit of Service* form (CSX102) online at

#### File the Forms

After serving the parties, file the *Motion to Contest Support Judgment Levy* along with the *Affidavit of Service* with court administration in the county where the hearing is to take place.
