

Instructions to Apply for an Order for Protection
Cov Lus Qhia Thov Tsab Ntawv Tiv Thaiv
(Minn. Stat. § 518B.01)
(Minn. Txoj Cai § 518B.01)

What is an Order For Protection?

An Order for Protection (OFP) is an order signed by a judge that may help protect you from domestic abuse. An OFP orders the abuser not to contact, harm or threaten to harm you, your children or other people the judge agrees to list on the order. You can also ask the judge to order the abuser to do certain things or stop doing certain things to help keep you safe.

Tsab Ntawv Tiv Thaiv Yog Dab Tsi?

Tsab Ntawv Tiv Thaiv (Order for Protection (OFP)) yog ib tsab ntawv ntswj uas kos npe tso cai los ntawm tus kws txiav txim plaub ntug kom pab tiv thaiv koj ntawm txoj kev tsim txom hauv vaj tse. Tsab OFP ntswj kom tus neeg tsim txom tsis txhob tuaj cuag, ua mob los yog hauv yuav ua phem rau koj, koj cov me nyuam los yog lwm cov neeg uas tus kws txiav txim plaub ntug pom zoo teev rau hauv tsab ntawv txwv. Koj puav leej thov tau kom tus kws txiav txim plaub ntug txwv tus neeg tsim txom kom nws ua qee yam los yog kom nws tsum tsis txhob ua qee yam koj thiaj li nyob nyab xeeb.

Who May Apply for an OFP?

The person applying for the OFP is called the petitioner. The abuser is called the respondent. The petitioner may apply for an OFP if domestic abuse has occurred AND if the petitioner and respondent are family or household members. **Please see the legal definitions below to determine if domestic abuse exists in your situation and if the petitioner and respondent are family or household members.**

Leej Twg Thiaj Thov Tau Tsab OFP?

Tus neeg ua ntawv thov tsab OFP yog hu ua tus neeg foob. Tus neeg tsim txom yog tus neeg raug foob. Tus neeg foob yuav thov tau tsab OFP yog txoj kev tsim txom hauv vaj tse tau muaj tshwm sim THIAB yog tus neeg foob thiaj tus neeg raug foob yeej yog ib yim neeg los yog cov tib neeg hauv vaj hauv tsev. Thov xyuas cov ntsiab lus lij choj txhais muaj nram no kom paub seb koj qhov xwm txheej puas yog kev tsim txom hauv vaj tse thiaj tus neeg foob thiaj tus neeg raug foob puas yog ib yig neeg los yog cov tib neeg hauv lub tsev neeg.

In certain circumstances, a petitioner may also apply **on behalf of** another person. For example, a petitioner may apply on behalf of a minor child if there has been domestic abuse of the child by the respondent and the petitioner is:

- a family or household member of the child; or
- the child's parent or guardian; or
- a reputable adult age 25 or older, if the judge finds that it is in the best interest of the minor.

Muaj qee cov xwm txheej tus neeg foob puav leej thov pab rau lwm tus neeg. Piv txwv, tus neeg foob thov tau rau tus me nyuam yog tias tau muaj kev tsim txom hauv vaj tse rau tus me nyuam los ntawm tus neeg raug foob thiaj tus neeg foob yeej yog:

- *ib yim neeg los yog ib tug hauv tus me nyuam lub tsev neeg; los yog*
- *tus me nyuam leej niam leej txiv los yog tus neeg saib xyuas; los yog*
- *tus neeg laus muaj koob zoo hnuv nyoog 25 xyoos los yog laus dua, yog tias tus kws txiav txim plaub ntug pom tias nws yuav zoo tshaj rau tus me nyuam.*

A person aged 16 or 17 may apply for an OFP on his or her own if there has been domestic abuse and the respondent is someone the petitioner:

- is married to;
- was married to; or

- has a child with, if the judge finds that the petitioner has sufficient maturity and judgment and that it is in the best interest of the minor.

Tus neeg muaj hnub nyoog 16 los yog 17 xyoo yuav thov tau tsab OFP rau nws tus kheej yog muaj kev tsim txom hauv vaj tse thiab tus neeg raug foob yog ib tug uas tus neeg foob:

- *sib yuav nrog;*
- *sib yuav nrog yav dhau los; los yog*
- *muaj me nyuam nrog, yog tias tus kws txiav txim plaub ntug pom tias tus neeg foog yeej paub tab txaus thiab txiav txim siab tau yog thiab yuav zoo tshaj rau tus me nyuam.*

Where May the Petitioner Apply for an OFP?

The petitioner may apply for an OFP in the court:

- in the county where the petitioner lives;
- in the county where the respondent lives;
- in the county where the domestic abuse occurred;
- in any county where there is a pending or completed family court case involving the petitioner and the respondent or their minor children, such as a divorce or a child custody case; or
- in the court with jurisdiction over divorce actions.

Tus Neeg Foob Yuav Mus Thov Tsab OFP Ohov Twg?

Tus neeg foob mus thov tau tsab OFP hauv tsev hais plaub:

- *hauv lub cheeb nroog uas tus neeg foob nyob rau;*
- *hauv lub cheeb nroog uas tus neeg raug foob nyob rau;*
- *hauv lub cheeb nroog uas txoj kev tsim txom hauv vaj tse tshwm sim nyob rau;*
- *hauv txhua lub cheeb nroog uas tseem tab tom xyuas los yog lis tiav roob plaub ntawm tsev neeg uas txuam muaj nrog tus neeg foob thiab tus neeg raug foob los yog nkawd cov me nyuam me, xws li rooj plaub sib nrauj los yog sib faib me nyuam; los yog*
- *hauv lub tsev hais plaub uas lis txog cov kev sib nrauj.*

How Much Does It Cost to Apply for or Serve the OFP?

There is no cost to apply for an OFP. If the judge grants the OFP, the OFP must be personally delivered to, or served, on the respondent. There is no cost to the petitioner to serve the OFP on the respondent.

Kev Thov Tsab OFP Yuav Raug Nqi Npaum Cas?

Tsis muaj nqi thov tsab OFP. Yog tus kws txiav txim plaub ntug pom zoo muab tsab OFP, yuav tsum nqa kias los yog xa tsab OFP mus rau tus neeg raug foob. Tus neeg foob tsis tau them nqi xa tsab OFP mus rau tus neeg raug foob.

Definitions:

Cov Ntsiab Lus Txhais

1. **Domestic Abuse** is defined as any of the following conduct between family or household members, regardless of whether this conduct has ever been reported to the police:

Kev Tsim Txom Hauv Vaj Tse yog txhais raws li txhua cov yam ntxwv nram no uas tshwm sim hauv ib yim neeg los yog ntawm cov neeg hauv tse, tsis hais yuav ceeb toom rau tub ceev xwm lawm los tsis tau:

- a. Actual physical harm, bodily injury, assault (such as hitting, kicking, slapping, pushing, stabbing), or fear of imminent physical harm, bodily injury or assault (such as verbal threats, threatening gestures); or

Kev ua mob kias rau lub cev, raug mob rau lub cev, tsim (xws li ntaus, ncaws, npuaj, thawb los yog nkawg), los yog ntshai tsam ua mob rau lub cev kias, raug mob rau lub cev los yog tsim (xws li hais lus hawv, yoj teg yim taws hawv); los yog

- b. Terroristic threats (such as a threat to kill, break bones, or threatening someone with a knife or a gun); or
Cov kev hawv ua phem (xws li hawv yuav tua, ua kom txha dam, los yog xuas riam los yog phom taw hawv ib tug neeg); los yog
- c. Criminal sexual conduct with an adult (such as forced sex or forced contact with intimate body parts, even if the parties are married) or any form of sexual contact with a child; or
Kev yuam ua dev ua npua txhaum cai nrog ib tug neeg laus (xws li yuam deev los yog yuam chwv yas cev, txawm ob tug neeg yeej yog txij nkawm lawm) los yog lwm hom kev ua dev ua npua rau ib tus me nyuam; los yog
- d. Interference with an emergency call (intentionally interrupting or preventing someone from placing an emergency call.)
Cuam tshuam tsab xov tooj hu cuag kev pab kub ceev (txhob txwm tshuam los yog tsis kheev ib tug neeg hu xov tooj cuag kev pab kub ceev.)

2. **Family or household members** are defined as:

- a. Married persons
- b. Persons who were married but are now divorced
- c. Parents, children
- d. Persons related by blood or adoption (such as brothers, sisters, uncles, aunts, or grandparents)
- e. Persons who live together now or who lived together in the past
- f. Persons who have a child together, even if they have not been married or lived together
- g. Persons who have an unborn child together
- h. Persons involved in or who were involved in a significant romantic or sexual relationship (regardless of sexual orientation)

Yim neeg los yog cov neeg hauv tsev yog txhais tias:

- a. *Cov neeg sib yuav*
- b. *Cov neeg uas sib yuav dhau los tiam sis tam sim no sib nrauj lawm*
- c. *Cov niam txiv, cov me nyuam*
- d. *Cov neeg sib txheeb raws roj ntsha los yog raws kev saws (xws li kwv tij, viv ncaus, txiv ntxawm txiv hlob dab laug, phauj, los yog niam pog txiv yawg)*
- e. *Cov neeg uas nyob ib lub tsev ua ke tam sim no los yog tau nyob ib lub tsev ua ke yav dhau los*
- f. *Cov neeg uas muaj me nyuam ua ke, txawm tsis tau sib yuav los yog tsis tau nyob ua ke dhau los*
- g. *Cov neeg uas xeeb muaj tus me nyuam hauv plab tsis tau yug ua ke*
- h. *Cov neeg muaj kev sib hlub los yog kev sib deev tam sim no los yog yav dhau los (tsis hais hom zeej xeeb twg li)*

If your application DOES NOT involve "domestic abuse" AND "family or household members" as defined above, you cannot apply for an OFP. However, you may still be able to apply for a Harassment Restraining Order (HRO). Please ask at the court administrator's office for HRO forms and instructions to see if you qualify.

Yog koj tsab ntawv TSIS txuam nrog "kev tsim txom hauv vaj tse" THIAB "yim neeg los yog cov neeg hauv tsev" raws li txhais saum no, koj yuav thov tsis tau tsab OFP. Tiam sis koj yeej tseem thov tau Tsab Ntawv Txwv Kev Zes Ua Phem (HRO). Thov nug lub chaw lis plaub ntug txog cov ntawv HRO thiab cov lus qhia thov seb koj puas tsim nyog thov tau.

If your complaint DOES involve "domestic abuse" AND "family or household members," you may complete the Petitioner's Affidavit and Petition for Order for Protection (Form OFP102) according to the following instructions.

Cov tsev hais plaub yuav tsum muab cov ntawv yooj teb thiab kev pab koj sau thiab teb tsab ntawv no. Tus neeg ua hauj lwm hauv tsev hais plaub qhia tsis tau tswv yim kev cai lij choj pab koj.

Please consider talking with an advocate to learn more about applying for an OFP and to help you stay safe. An advocate may also be able to connect you with an attorney experienced with helping people in your situation. Tus kws pab tswv yim yuav pab koj mus cuag tau ib tug kws lij choj uas tau pab dua cov tib neeg muaj koj qhov xwm txheej dhau los. Kom koj mus cuag tau ib tug kws pab tswv yim, koj hu tau rau Day One[®] MN tus xov tooj Hu Cuag Kev Pab Txog Kev Ua Phem Hauv Vaj Tse ntawm 1.866.223.1111.

In the box marked "County," write the name of the county in which you are applying for the OFP.
Hauv kem kos “Cheeb Nroog,” sau lub npe cheeb nroog uas koj thov tsab OFP.

Court administration staff will fill in the "Judicial District" and "Court File Number" box.
Tus neeg lis dej num hauv tsev hais plaub yuav sau rau “Txhooj Hais Plaub” thiab “Zauv Cim Rooj Plaub.”

On the line above the word "Petitioner," write your own name. If you are seeking protection for yourself, check the box that states, “and for her/himself.” If you are applying on behalf of another person or persons, write those persons’ names on the lines below the words “On behalf of.” On the line above the word "Respondent," write the name of the person you want to be protected from.

1. Check the box next to all of the people that need protection. You may check more than one box.
Kos kem tom ntej ntawm tag nrho cov tib neeg xav tau kev tiv thaiiv. Koj kos tau tshaj ib kem.

2. Write your name, complete address, race, gender and date of birth. **If you do not want the respondent to know your address, or if you do not want your address to be part of the public file, DO NOT WRITE YOUR ADDRESS HERE; instead, check the box indicating you want your address kept confidential and provide your address separately to court staff on the Confidential Address/Phone Request form OFP107.**

3. If you want to be notified by email when the respondent is served with the OFP, include your email address here.

Yog koj xav kom peb sau ntawv email tuaj faj seeb qhia kom koj paub tias peb tau xa tsab OFP rau tus neeg raug foob, qhia koj qhov email rau ntawm no.

Please note that this is the only email you will receive from the court about the OFP unless you have signed up to receive other court notices via email. It will only be possible for the court to notify you by email when service information is received by the court from law enforcement. A technical or other error could occur preventing the successful delivery of the email. You have other options to learn of the service of the OFP on the respondent, including contacting law enforcement directly. The email address you provide must be valid in order to receive this notification of service. This email address will be seen by the respondent.

4. Write the name, complete address, race, gender and date of birth of the respondent. If you do not know the respondent's exact date of birth, give an approximate age or approximate date of birth. If the respondent is a minor, write the name and address of the respondent's parent or legal guardian.

5. List all of the persons that need protection other than you, if any. Then, complete the chart with the information required for each person you have listed.

6. List all minor children that you and respondent have together, biological or adopted, who you did not already list at #5, if any.

Sau tag nrho cov me nyuam uas koj thiab tus neeg raug foob neb muaj ua ke, cov yug los yog cov saws, uas koj tsis tau teev muaj ntawm nqe 5, yog tias muaj.

7. List all minor children living with you, who you did not already list at #5 or #6, if any.
Sau tag nrho cov me nyuam me nyob nrog koj, uas koj tsis tau teev muaj ntawm nqe 5 los yog nqe 6, yog tias muaj.
8. Check all of the boxes that describe your relationship to the respondent or the relationship between other persons needing protection and the respondent. To qualify for an OFP, you only need to meet one of these requirements. If you check the last box, "Significant romantic or sexual relationship," you must also fill in the blanks next to it.

9. This section needs to be completed if you or other persons needing protection have an OFP **in effect now** with the respondent. Answer all of the questions here, if known.
*Yuav tau teb kom tiav ntu no yog koj los yog lwm cov neeg xav tau kev tiv thaiv tau muaj ib tsab OFP **tam sim no** nrog tus neeg raug foob. Teb tag nrho cov nqe lus nug ntawm no, yog paub teb tau.*
10. This section needs to be completed if you or other persons needing protection have had an OFP **in effect in the past**. Write the court file number and the county and state where the past OFP was filed, if known.
*Yuav tau teb kom tiav ntu no yog koj los yog lwm cov neeg xav tau kev tiv thaiv tau muaj ib tsab OFP **yav dhau los**. Sau tus zauv cim rooj plaub thiab lub cheeb nroog thiab lub xeev uas zwm muaj tsab OFP, yog paub qhia tau.*
11. If you and the respondent have been jointly involved in other Court cases, check the box(es) of the types of cases and write the case type, number, state and county, year the cases were filed and the names of any children involved, if known.

12. Write details about the most recent domestic abuse committed by the respondent. See the DEFINITIONS on Page 2 of these Instructions to be sure that what you describe are acts of domestic abuse. If possible, answer the questions provided. Be as specific as possible. Include the date or approximate date that the abuse occurred.

You may also use an additional sheet of paper to describe the abuse. Please provide the court administrator with any additional sheets of paper describing the abuse.

13. If there is a history of abuse between you or other persons needing protection and the respondent, briefly describe that abuse here.
Yog yeej muaj keeb kwm kev tsim txom ntawm koj los yog ntawm lwm cov neeg xav tau kev tiv thaiv thiab tus neeg raug foob, piav me ntsis qhia txog txoj kev tsim txom rau ntawm no.
14. Write why you believe that the domestic abuse will continue and why you or other persons needing protection are in immediate danger from the respondent.
Sau seb vim li cas koj thiaj ntseeg tias txoj kev tsim txom hauv vaj tse yeej yuav muaj musntxiv thiab vim li cas koj los yog lwm cov neeg xav tau kev tiv thaiv thiaj yuav ntsib teeb meem tsis zoo los ntawm tus neeg raug foob.
15. Check yes if the respondent works or attends school at the same place where you or other persons needing protection work or attend school. Check no if the respondent does not work or attend school at the same place as you or other persons needing protection.
Kos yog, yog tias tus neeg raug foob mus ua hauj lwm los yog mus kawm ntawv ntawm tib qho chaw koj los yog lwm cov neeg xav tau kev tiv thaiv mus rau. Kos tsis yog, yog tias tus neeg raug foob tsis mus ua hauj lwm los yog mus kawm ntawv ntawm tib qho chaw koj los yog lwm cov neeg xav tau kev tiv thaiv mus rau.

Requests for Relief – No Hearing Required
Cov Lus Thov Kev Cawm – Tsis Tas Muaj Rooj Sib Hais Plaub

You may ask the judge to order the respondent to do certain things or to stop doing certain things to help keep you safe. This is called “requesting relief.” Some types of relief can be ordered by the judge without requiring a hearing, but other types of relief require a hearing to be held.

Koj thov tau tus kws txiav txim plaub ntug kom ntswj tus neeg raug foob ua tej yam twg los yog txwv kom txhob ua tej yam twg thiaj pab koj nyob nyab xeeb.
