- 1. Welcome Judge Holton Dimick
- **2. October 8, 2015 Minutes –** The minutes were approved as written.
- **3.** MCBW Legislative update Rebekah Moses provided an overview of proposed legislative changes for the session that starts in February 2016. (see handout)
- **4. Retreat update** Judge Holton Dimick provided an update on the Executive Committee retreat that was held on October 16, 2015. Executive Committee members:
  - Reviewed and made proposed changes to the bylaws
  - Updated the current strategic plan and established a timeline for the 2016 strategic plan.
    - Members will brainstorm 2016 goals at their November meetings. The FVCC will brainstorm goals at the December meeting and finalize the 2016 Strategic Plan at the January meeting.
  - Reviewed attendance for 2015 per the existing bylaws. FVCC members were contacted to discuss continued membership in 2016.
  - Discussed the relationship between the FVCC and the DV Court Steering Team.
    - A survey will be conducted of both groups and results will be presented at the December meeting.
- **5. Discussion and vote on draft amended FVCC Bylaws** The amended Bylaws passed as written (attached). Bylaws will be available on the FVCC website. Changes include:
  - New format
  - Shall replacing the word will.
  - New minimum number of times the Council, the Executive Committee and the four committees are required to meet.
  - Regular committee meeting minutes being taken at the direction of the committee chair.

- Regular committee members selecting the committee chair (versus the FVCC Co-Chairs making that appointment).
- Deleted the requirement that voting members must attend four consecutive FVCC meetings per year.
- **6.** MNCIS review Judge Cutter Continue to December meeting.
- **7. DV Court new location update** Judge Cutter Continue to December meeting. Lydia Morales reported that DV Court has moved to the HCGC from the PSF.

**Advocate** – Stephanie Avalon reported the advocates met October 27<sup>th</sup> and discussed problems, along with potential solutions, to issues they see on the protection order calendar. **Civil** – Christy Snow Kaster reported the committee met on October 22nd. **Juvenile** - Referee Angela Wilms reported the committee met and reviewed the outcomes of the recent Resource Fair and CLE.

**Criminal** – Katie Brey reported on behalf of Michelle Jacobson. The committee did not meet this month. Michelle encouraged everyone to attend the December 2nd event, The Use of Technology to Stalk, in the HCGC Auditorium (see attached flyer).



### MCBW'S PROACTIVE AGENDA

- ORDER FOR PROTECTION (OFP):
  - o **FILING FEES:** <u>Issue</u> Current statute gives the courts discretion to charge respondents a filing fee in Order for Protection (OFP) proceedings, and some district courts are now charging respondents. This creates an unequal system and a due process concern. While petitioners pay nothing to fully engage in the process, respondents are being required to pay, creating a barrier for respondents' opportunity to be heard. <u>Solution</u> Amend the Domestic Abuse Act to waive respondent filing fees.
  - o **EXTENSIONS:** <u>Issue</u> Under current statute, certain limited OFPs can be granted without a hearing, but only if the respondent chooses to waive the right to a hearing. However, an <u>extension</u> of a <u>limited-relief</u> OFP requires a hearing even if the petitioner and respondent do not want a hearing for the limited-relief OFP. <u>Solution</u> Allow limited-relief OFPs to be granted after notice and opportunity to be heard, without a hearing requirement.
- CHILD PROTECTIVE SERVICES (CPS): In response to the Governor's CPS Task Force
  recommendations and 2015 legislation, DHS is implementing CPS reforms that directly
  intersect with domestic violence. Further legislation is being considered for the 2016 session.
  MCBW has convened a CPS workgroup from our membership to help identify and address
  concerns with implementation, and to monitor and provide input on any future legislation.

### **EMERGING ISSUES**

- FIREARM SAFETY: MCBW is concerned about the direct link between access to firearms and domestic violence. On average, 50% of Minnesota DV homicides are committed with a firearm. MCBW supports gathering comprehensive data on DV homicides and firearms usage in order to gain a deeper understanding of the underlying problems and to develop policy solutions that are informed by evidence.
- LAW ENFORCEMENT USE OF BODY CAMERAS: Data resulting from law enforcement's use
  of body cameras implicates victim safety and perpetrator accountability. MCBW will monitor
  and respond to legislation regulating body camera data to ensure victim safety and privacy is
  a priority.
- PRISON POPULATION: MCBW is monitoring the Prison Population Task Force and will
  respond to policy-related legislation to ensure abusers will be held accountable.
- **REVENGE PORN:** The misuse of technology and non-consensual distribution of images and identifying information are tactics of abusers. Such acts greatly impact victim safety and well-being. MCBW will monitor and respond to any "revenge-porn" legislation.
