**IT IS YOUR RESPONSIBILITY—NOT THE COURT'S--TO COMPLETE  
THE FOLLOWING STEPS TO ENSURE YOU ARE VALID TO DRIVE:**

**IF YOU ARE PAYING YOUR FINE PRIOR TO THE SCHEDULED DATE OF  
SUSPENSION:** *DPS standard processing time for reinstatements is 24 hours after payment has been documented into the court management system. You are responsible to call DPS to determine (1) it has a record of the fine being paid in full; (2) the amount of any reinstatement fees which may be owing to DPS; and (3) that your driver's license is now valid.*

**IF YOU ARE PAYING YOUR FINE ON OR AFTER THE SCHEDULED DATE OF  
SUSPENSION:** *Take your receipt to the DPS office (directions below) to evidence you have paid your fine and avoid suspension of your license or, if your license has already been suspended, to pay any reinstatement fees which may be owing directly to the DPS. Visit [www.mndriveinfo.org](http://www.mndriveinfo.org) to confirm your license is valid before you drive or you will be at risk of receiving a driving after suspension charge.*

**Directions to the Department of Public Safety**

**From the West:**

*Hwy. 94 east to the 10<sup>th</sup> Street exit.  
Straight on 10<sup>th</sup> to Cedar. Right on Cedar.  
The 2<sup>nd</sup> stop light is 7<sup>th</sup> Street.  
Town Square is on the far left corner of  
Cedar St. & 7<sup>th</sup>*

**From the East:**

*Hwy. 94 west to 6<sup>th</sup> St. exit, (this is a left  
exit).  
Straight on 6<sup>th</sup> Street to Minnesota St.  
Right on Minnesota Street.  
Town Square is one-half block up on left.*

**From the North:**

*Hwy. 35E to 10<sup>th</sup> St. Exit  
Straight on 10<sup>th</sup> then left on to Cedar St.  
The 2<sup>nd</sup> stop light is 7<sup>th</sup> St.  
Town Square is on the far left corner of  
Cedar St. & 7<sup>th</sup>.*

**From the South:**

*Hwy. 35E North to 11<sup>th</sup> St. exit.  
Straight on 11<sup>th</sup> St to 7<sup>th</sup> St.  
Town Square is on the far left corner of  
Cedar St. & 7<sup>th</sup>.*
