Regards.

I lack many words at this sad hour. I am a former/current US Government Authority involved in a post-Civil Rights Movement Sociopolitical Hostage Crisis with interest in intervening in the probate proceedings linked to the recent and sudden death of Pop Icon Prince, whose official name is Prince Rogers Nelson.

I've prepared a brief Written Statement of Claim, absent any Memorandum of Law in Support of the Written Statement of Claim unless the copied notarized Affidavit detailing some significant facts of my now 40 years long post-Civil Rights Movement Sociopolitical Hostage Crisis provides satisfactory explanation of this communication to your Court.

Primarily, however, it must be noted that the fact of my Hostage Crisis has prevented resolution of a legal injury which first occurred between 1983-1987 at such time that Prince is believed to have delivered a box of requested legal documents to me via the brother of my under duress hostage-related father at a home located on Vaughn Road in Athens, Clarke County, GA. Based on terroristic threats issued against me by Rev. Abraham Mosley's daughter now named Cindy Audrella Mosley Robinson, that box along with a take-out order of food was stolen at gunpoint from my possession and I was unable to return to my hostage-related residence in Atlanta, Fulton County, GA with it. In the mid-1980s, against my wishes, Cindy Audrella Mosley used "means of identification" stolen now more than 45 years ago to meet the Pop Star and eventually to travel to his Estate(s) in or near Minneapolis, where I may have recovered from work-related injuries in the early 1970s and from school-related Gun Violence in the mid-1980s.

In my legal/original identity, of Gen. Dr. Karolina R. Kennedy Ferrara, I am a Harvard-educated Attorney/Judge and Surgeon/Biomedical Researcher. My legal/original identity is a WITSEC identity linked to the kinship of 35<sup>th</sup> US President John F. Kennedy. My actual and true lineage links to the kinship of Oil Industrialist and Philanthropists John D. Rockefeller, Sr. and Laura Spelman Rockefeller and the Royal Family of the Principality of Monaco. I was a legally-declared Billionaire prior to such time that my current Hostage Crisis began, and had a significant affiliation with Spelman College in Atlanta, GA.

I'm currently making concerted efforts to resolve the Hostage-Taking of US Government Authority Gen. Dr. K. K. Ferrara, my legal/original identity at the sad hour in American History when I was involved in a violent Home Invasion and when my 100% Caucasian/White physical appearance was grossly altered by a brutal Bioterrorism Attack that led to my Kidnapping and eventual Hostage-Taking which has the makings of a Global Political Scandal.

Pursuant to MINN. STAT. 524.1-106 (2015), "[w]henever fraud has been perpetrated in connection with any proceeding or in any statement filed under this chapter or if fraud is used to avoid or circumvent the provisions or purposes of this chapter, any person injured [...] may obtain appropriate relief against the perpetrator of the fraud or restitution from any person, [...] benefiting from the fraud, whether innocent or not. ..." Specific Gun Violence against me in the mid-1990s is believed linked to the manner in which I learned of Prince's sudden death.

Further, it is believed that my hostage-takers and their children, including but not limited to my hostage-related parents with whom I currently reside (*dangerously*) due to suspected ongoing fraud and extortion, have been seeking compensation from Prince since 1985 or so. Additionally, Prince is believed to have taken into his possession artifacts of mine which were taken with my "poisoned" body to a property connected to former Chicago Bulls player Michael Jordan after an attempt on my life in Denver, CO in October 1997. At that time, I was a Graduate Student at the Iliff School of Theology in Denver, CO. Months earlier, Prince greeted me briefly when I was escorted into strange court proceedings presided over by Judge Ito, who'd presided over the OJ Simpson Trial. It was then that various entities sought to assist in ending my Hostage Crisis by returning to me partial access to some of my funds via their confirmation of my legal/original identity in light of my very serious Bioterrorism-related injuries. Your Honor, this overall matter may warrant a request for a Section 331 Executive Order in the event of any uprisings, insurrections or rebellions

that place the lives of any (other) Government workers or the General Citizenry in immediate danger, which would need to be approved by 2/3 US Congress in the event that President Obama refused such an Order.
