ORDER ESTABLISHING MINNESOTA ALTERNATIVE DISPUTE RESOLUTION IMPLEMENTATION COMMITTEE

WHEREAS, the Joint Supreme Court/Minnesota State Bar Association Task Force on Alternative Dispute Resolution found that ADR processes hold substantial promise for an earlier, less costly, and more satisfactory disposition of many civil cases; and

WHEREAS, legislation was enacted during the 1991 Session authorizing the Supreme Court to establish a statewide system for the use of alternative dispute resolution techniques for the resolution of civil cases;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Alternative Dispute Resolution Implementation Committee be, and hereby is, established to:

1. Recommend rules of practice and procedure for the use of alternative dispute resolution techniques in the trial courts;
2. Recommend standards for the training of and qualifications of alternative dispute resolution neutrals; and
3. Recommend necessary statutory amendments to aid in the implementation of the system.


