**Order Creating and Appointing
Members to the Judicial Branch
Strategic Plan Implementation Committee**

WHEREAS, over a nine month period the Conference of Chief Judges' Strategic Planning Committee, comprised of trial and appellate judges and administrators, drafted a proposed Judicial Branch Strategic Plan for the Year 2005; and

WHEREAS, the Year 2005 Strategic Plan was reviewed and approved by the Conference of Chief Judges and this Court; and

WHEREAS, this Court has received requests for the creation of a system-wide Strategic Plan Implementation Committee from Chief Judge Edward Toussaint, Jr. of the Minnesota Court of Appeals; Judge William Walker, Conference of Chief Judges' Chair; Judge John Stanoch, Minnesota District Judges Association President; and David Carlson, Minnesota Association for Court Administration President;

NOW THEREFORE, IT IS HEREBY ORDERED, that the Judicial Branch Strategic Plan Implementation Committee be, and hereby is, created and charged with the following:

1. Plan for and implement the Year 2005 Strategic Plan;
2. Recommend requests for funding and introduction of legislation and/or rule changes in order to implement projects, as may be required;
3. Report periodically on the progress of implementation to the appellate courts, Conference of Chief Judges and court-related associations.
