ORDER

WHEREAS, the Supreme Court Task Force On Juvenile Justice has recommended amendments to the Rules of Juvenile Justice; and

WHEREAS, this Court has concluded that the creation of an advisory committee is necessary and appropriate to review the Rules on Juvenile Procedure.

4. Judge Gary Crippen, Court of Appeals, and Barry Feld shall serve as reporters to the committee.


