ORDER PROMULGATING AMENDMENTS TO THE RULES OF THE SUPREME COURT ON LAWYER REGISTRATION

The Rules of the Supreme Court on Lawyer Registration allocate lawyer registration fees among the supreme court's regulatory boards in order to fund the operations and expenses of those boards. *See* Rule 10(A), Rules on Lawyer Registration; *see also* Rule 1, Rules on Lawyer Registration (explaining the purpose of registration fees, "to help defray the cost" of regulating the profession). The Client Security Board has advised the court that its existing reserves are adequate for current and projected budget needs, while the Office of Lawyers Professional Responsibility has identified current and projected expenses that could be funded through a re-allocation of the registration fees. The court has considered an adjustment to the allocation of registration fees, which will not increase those fees, and concludes that a re-allocation should be made.

Based on all the files, records, and proceedings herein, and pursuant to the inherent authority of this court to regulate the practice of law,

IT IS HEREBY ORDERED that the Rules of the Supreme Court on Lawyer Registration are amended as shown in this order. The Rules as amended are prescribed and promulgated to be effective for Lawyer Registration Statements that are due to be filed or are filed on or after October 1, 2019.
