THIS CONFIDENTIAL SETTLEMENT AGREEMENT AND RELEASE ("Settlement Agreement") is made and executed this 2 day of January, 2017, by and between Bremer Trust National Association, in its role as Special Administrator, or by the successor Special Administrator(s) or successor Personal Representative(s) (hereinafter referred to as "Special Administrator" regardless of legal title) in the Estate of Prince Rogers Nelson, Decedent, Carver County, First Judicial District, Probate Division, Minnesota, Court File No. 10-PR-16-46 (the "Matter") and Make-A-Wish Foundation of Minnesota, a Minnesota non-profit corporation, also operating under the assumed name Make-A-Wish Minnesota, a disallowed claimant ("Claimant" or "Make-A-Wish Minnesota") in the Matter. Special Administrator and Claimant are individually referred to herein as "Party" and jointly as "Parties".

## RECITALS




