**STIPULATION TO STAY  
PROCEEDINGS**

Petitioner Mixed Blood Theatre (“Petitioner”) and Comerica Bank & Trust, N.A. (“Comerica”), personal representative of Decedent’s estate (collectively, the “Parties”), jointly stipulate and move the Court for an Order staying any proceedings on Petitioner’s Petition in this matter pending the resolution of the civil action, captioned *Mixed Blood Theatre v. Paisley Park Enterprises, LLC, et al.*, Court File No. 10-CV-17-166, Carver Cnty. Dist. Ct. (the “Mixed Blood Lawsuit”).
