THE SPECIAL ADMINISTRATOR'S REQUEST TO MODIFY THE MOTION TO COMPEL DOCUMENTS FROM L. LONDELL MCMILLAN

Late in the day on January 6, 2017, counsel for Tyka Nelson and Omarr Baker filed a "Motion to Compel L. Londell McMillan to Produce Information Necessary to Facilitate the Appointment of a Personal Representative."

Without taking a position on the propriety of discovery on Mr. McMillan generally, nor on the procedural propriety of the Motion to Compel, the Special Administrator asks the Court to at least modify request #8. In that request, the moving parties seek to compel "Any and all documents—physical and electronic—that reference or relate to any communication [Mr. McMillan] had with Traci Bransford prior to June 16, 2016." To the extent the moving parties seek any communication between Ms. Bransford, a partner at Stinson Leonard Street and counsel for Bremer Trust, and Mr. McMillan it would only be relevant after April 21, 2016, when Prince Rogers Nelson passed away. But more importantly, the Special Administrator objects that those communications could contain material that is protected by the attorney-client privilege or attorney work product. *See generally* Minn. R. Civ. P. 45.03 (c)(1)(C) (authorizing motions to

quash or modify subpoenas to third parties if the responsive documents could contain protected material).

As such, to the extent the Court contemplates compelling the production of documents by Mr. McMillan, Bremer Trust asks that request #8 be limited to documents between April 21 and June 16, 2016, and that counsel for Bremer Trust be allowed to review any documents for privilege before they are produced by Mr. McMillan.
