CLAIM

I Lily Cassandra Alphonsis hereby seek the help of this Court to obtain two videodisc and its contents used in the remake of the song "The Beautiful Ones." The two videodisc which contain confidential information about the late entertainment icon, Michael Jackson, two biological children, confidential information about the music industry, and also contain video narrative of the incidents that led to his death. The CDs were given to the late Mr. Nelson around March, 2015, for creative purposes by Mr. Williams and myself. Mr. Nelson incorporated some of the videodisc's

Content in the remake of his song, "The Beautiful Ones," a tribute song to the late Michael Jackson and seven other entertainment icons who died as a result of induced chemicals in their heart.

The videodisc also contain confidential information about me. Hence, I do not want the disc in the wrong hands.

A few days after I learned about Mr. Nelson's untimely demise, I sent a message to Sheriff Jim Olson, through my manager, and requested for more information about the attorneys handling Mr. Nelson's estate. I was led to his sister Ms. Tyka Nelson and Bremer Trust. However, my efforts to reach them did not produce any results.

On May 9, 2016, after I discovered that this court is assigned to handle his estate, I wrote a letter to Hon. Kevin W. Eide. On October 10, 2016, the letter was returned to me, because the Court Administrator requires a more "formal written statement of claim." I do not know the requirements to file a probate claim in this court. Therefore, I am using this format to state my claim. It was never my intention to pursue a claim against his estate in court. However, since all my efforts to reach them has been unsuccessful, I am hoping that through this channel, the court would assist me in obtaining the two video discs from Mr. Nelson's estate without any struggles.

I am also hoping that Mr. Nelson's estate would soon release the remake of "The Beautiful Ones." I am not interested nor requesting any proceeds/money from his estate, but just requesting the two videodisc to be returned to me. My name is written on the disc with a pink mark. Mr. Nelson kept the two CDs in his safe always. The remake of "The Beautiful Ones" has already been mastered, and it would have been released on June 25, 2016. The release of the song will reveal the truth about


many deaths/murders in the entertainment industry. And it will give the government a clear picture of what has been going on behind the scenes in the entertainment industry and the truth behind some of the deaths/murders of its icons.

The two video discs were given to me by Michael Jackson to forward one to his mother, Katherine Jackson and the other one to CNN Correspondent Anderson Cooper.

The third copy was given to me for my records. While one of the CDs was stolen by Homeland Security agents that gained access into my storage unit in May 2013, these two copies were kept abroad and were delivered to me for Mr. Nelson's use in March 2015.

I am praying that this court will order Mr. Nelson's estate to relinquish the compact disc to me, and also release the remake of Mr. Nelson's song "The Beautiful Ones." Releasing the song will expose the truth, and also help save someone's life. My freedom from incarceration has also depended on this project. But for now, the song must be released to shed the light from the darkness that is killing our entertainment icons.
