Counsel should be present and be prepared to begin whenever their case is called.

Guests and visitors are required to pass through screening to enter the courtroom and are not permitted to enter with bags larger than $4.5 \times 6.5 \times 3$ inches.

Security at the Judicial Center: All attorneys, guests, and visitors are required to pass through security screening to enter the Judicial Center.
