1. Pursuant to Minn. Stat. § 481.13, subd. 1(c), establishing a lien for compensation for services rendered and costs advanced in the sum of \$214,652.11, comprised of: 1) \$213,350.46 for legal services rendered and 2) \$1,301.65 for costs incurred from on or about April 27, 2016 through November 29, 2016 by Lien Claimant Lommen Abdo, P.A. to Sharon L. Nelson, Norrine P. Nelson, and John R. Nelson's (the "Nelsons") in connection with the above-captioned Estate, determining the amount of said lien and ordering the entry of judgment in favor of Lien Claimant Lommen Abdo, P.A. against the Nelsons in the determined amount of said lien.
