**ORDER HOLDING GREGG WALKER  
IN CONTEMPT OF COURT**

---

The above-entitled matter came before the undersigned on May 20, 2019 on the Motion of Comerica Bank & Trust, N.A., to Hold Gregg Walker in Contempt of Court. Based on the Motion, supporting declarations, and the entire file, records, and proceedings herein, the Court hereby makes the following:

**ORDER**

1. Gregg Walker is in contempt of this Court's February 13, 2019 Order.
2. The Court imposes a conditional fine on Mr. Walker in the amount of \$250.00 based on his violation of the February 13, 2019 Order. Mr. Walker can purge the contempt and avoid paying the fine by fully complying with his obligations under the February 13, 2019 Order, namely:

provide counsel for Comerica all communications and related documents with any third-parties (including, but not limited to, the two entities referenced in the February 8, 2019 Letter filed by Alfred Jackson, Omarr Baker, and Tyka Nelson) that included confidential information that belongs to the Estate. Without limiting the foregoing, Mr. Lythcott and Mr. Walker shall provide all communications and documents related to the "pitch book" attached to the February 11, 2019 letter filed by White Wiggins & Barnes, LLP. Mr. Lythcott and Mr. Walker shall also provide an access log to the data site referenced in the White Wiggins & Barnes, LLP letter that discloses all parties who accessed the site and what they reviewed.

3. Within 10 days, Mr. Walker shall fully comply with the February 13, 2019 Order by producing all communications and documents required by the February 13, 2019 Order.

4. The Court orders Mr. Walker to reimburse the Estate in the amount of \$\_\_\_\_\_ based on the costs and attorneys fees incurred by Comerica Bank & Trust, N.A. bringing the motion.

5. This Order is limited solely to Comerica Bank & Trust, N.A.'s Motion to Hold Mr. Walker in Contempt of Court for violating his obligations to produce records under the February 13, 2019 Order. The Court will address violations by Mr. Walker of his confidentiality and non-disclosure obligations to the Estate by separate order.
