CHRIS BAKEMAN states:

- 1. My name is Chris Bakeman, I make this affidavit upon personal knowledge of the facts set forth herein.
- 2. I am a resident of 4460 Galtier St, Shoreview, Ramsey County, Minnesota.
 - 3. I am a volunteer for the Friends for Paul Wikstrom campaign.
- 4. On Saturday, August 31, 2024, I took photos of a residence located at 3084 Payne Ave, Little Canada MN 55117 and of an apartment building located at 2735 Rice St, Roseville MN 55113. (EX 8 18) I recorded the audio of the message that played when selecting the apartment directory button #103 listed for Johnson at 2735 Rice St, Roseville MN 55113. Having previously watched replays of his LWV Roseville 623 School Board Candidate Forum from October 7, 2021, two podcast appearances on Cities Speak on Nine North, and Curtis Johnson campaign ads I can affirm it was the voice of Curtis Johnson on the door recording. (EX 19)
- 5. I created a transcript of this audio message to preserve what was said by Mr. Johnson. (Ex. 267)
 - 6. On Monday, September 9, 2024, I took photos of a residence located

at 3084 Payne Ave, Little Canada MN 55117. (EX 20 - 23)

- 7. On Monday, September 16, 2024, I took photos of a residence located at 3084 Payne Ave, Little Canada MN 55117 and observed the Blue Mitsubishi Mirage MN license plate FVZ953 being present. (EX 24 27)
- 8. On Tuesday, September 17, 2024, I took photos and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 and two individuals after exiting the residence on the street walking two dogs. I took a photo and video of a Blue Mitsubishi Mirage MN license plate FVZ953 in the parking lot of Roseville City Hall. (28 30, 32 33)
- 9. On Wednesday, September 18, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed four vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 34, 35)
- 10. On Thursday, September 19, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed four vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 39 40)
- 11. On Friday, September 20, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 41, 42)

- 12. On Saturday, September 21, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 45, 46)
- 13. On Monday, September 23, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 49, 50)
- 14. On Tuesday, September 24, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 53, 54)
- 15. On Wednesday, September 25, 2024, I took a photo and video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 58, 59)
- 16. On Thursday, September 26, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 63)
 - 17. On Friday, September 27, 2024, I took video of a residence located

at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 66)

- 18. On Saturday, September 28, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed two vehicles parked in the driveway. (EX 69)
- 19. On Sunday, September 29, 2024, I took four videos of a residence located at 3084 Payne Ave, Little Canada MN 55117. In one of the videos the driveway showed two vehicles. In three of the videos the driveway showed three vehicles to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 74 77)
- 20. On Monday, September 30, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 79)
- 21. On Tuesday, October 1, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 83)
- 22. On Wednesday, October 2, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed two vehicles

parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 92)

- 23. On Thursday, October 3, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 94)
- 24. On Friday, October 4, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 97)
- 25. On Monday, October 7, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 102)
- 26. On Tuesday, October 8, 2024, I took morning and afternoon videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. I took additional video at the residence at approximately 5:52 p.m. showing one vehicle in the driveway, absent a Blue Mitsubishi Mirage MN license plate FVZ953. I then took a series of additional videos at the ISD 623 school board meeting at Anpetu Teca Education Center,

1910 County Rd B W, Roseville MN 55113. This included video of a Blue Mitsubishi Mirage MN license plate FVZ953 in the parking lot and vehicle contents which included campaign signage for Curtis Johnson for State Representative. I took video inside the ISD 623 meeting place which verified the presence of Curtis Johnson. After the ISD 623 meeting was concluded I took a series of additional videos at the residence located at 3084 Payne Ave, Little Canada MN 55117. In one of those videos, at approximately 9:02pm, a Blue Mitsubishi Mirage MN license plate FVZ953 can be seen returning to the driveway and Curtis Johnson can be seen exiting the vehicle and entering the residence. (EX 103 - 113)

- 27. On Wednesday, October 9, 2024, I took early morning and late evening videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. I also took a video of the same residence at approximately 6:17pm which showed two vehicles parked in the driveway excluding a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 114, 116 118)
- 28. On Thursday, October 10, 2024, I took early morning and late evening videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. I also took videos of the same

residence at approximately 8:13 p.m. and 9:34 p.m. which showed two vehicles parked in the driveway excluding a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 120 - 124)

- 29. On Friday, October 11, 2024, I took videos in the morning afternoon and evening of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 125 128)
- 30. On Saturday, October 12, 2024, I took video in the morning of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed Curtis Johnson managing items in the back seat of a Blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway, then proceeding by foot to an open garage door, shortly thereafter the garage door closes. Another video minutes later shows two vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. Another video later in the morning shows one vehicle parked in the driveway excluding a Blue Mitsubishi Mirage MN license plate FVZ953. A final video at 6:59 p.m. shows three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. (129 132)
- 31. On Sunday, October 13, 2024, I took four videos throughout the day of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi

Mirage MN license plate FVZ953. (EX 133 - 136)

- 32. On Monday, October 14, 2024, I took videos in the early morning, afternoon and evening of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a Blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 137 139)
- 33. On Tuesday, October 15, 2024, I took video at 6:58 a.m. of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed three vehicles parked in the driveway to include a Blue Mitsubishi Mirage MN license plate FVZ953. Following the video release by the Paul Wikstrom campaign stating Curtis Johnson does not reside in HD40B, at approximately 11:22 a.m., I captured video of Curtis Johnson entering the Blue Mitsubishi Mirage MN license plate FVZ953 in the driveway of 3084 Payne Ave. Little Canada MN 55117. At approximately 11:23 a.m., in another video capture, the Blue Mitsubishi Mirage MN license plate FVZ953 is seen driving north away from the residence located at 3084 Payne Ave, Little Canada MN 55117. In an educated guess Curtis Johnson and his Blue Mitsubishi Mirage MN license plate FVZ953 might be headed to an apartment building located at 2735 Rice St, Roseville MN 55113, I proceeded to that address and found Curtis Johnson parked in the east general parking area of the apartments among many other parked cars. I made eye contact with him, he recognized me and/or my black vehicle and immediately began to depart the parking lot. I made a u-turn in

my vehicle and took video immediately after this contact at 11:41 a.m., but Curtis Johnson and his Blue Mitsubishi Mirage MN license plate FVZ953 was able to quickly exit onto Rice Street and elude video capture. This morning would turn out to be the last time Curtis Johnson's Blue Mitsubishi Mirage MN license plate FVZ953 was seen and photographed by me at 3084 Payne Ave, Little Canada MN 55117 (two videos taken later in the day at 3084 Payne Ave, Little Canada MN 55117 are absent a Blue Mitsubishi Mirage MN license plate FVZ953 in the driveway, as are all remaining videos of the residence in the days to come). (EX 140 - 145)

- 34. On Wednesday, October 16, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed no Blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 146 148)
- 35. On Thursday, October 17, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed no Blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. Of note is the red Toyota Venza MN license plate KBL245 which in the last three videos of the day is (unusually) on the right (south) side of the driveway making a clear area on the left (north) side of the driveway. The reason for this becomes apparent on Friday October 18, 2024, when a POD is delivered to the left (north) side of the driveway. (EX 149 153)

- 36. On Friday, October 18, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed no Blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. However, pictures and video later in the day did show delivery of a POD to the left (north) side of the driveway with a POD serial number 142703BX. (EX 154, 157 160)
- 37. On Saturday, October 19, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. However, a series of videos did show the POD in the driveway as well as an open garage door and the believed to be wife of Curtis Johnson, Jill, packing items into a red Toyota Venza MN license plate KBL245. After greeting me with a "Hi" Jill was asked if they were moving and where they were moving, and she was verbally unresponsive to the questions. (EX 161 165)
- 38. On Sunday, October 20, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I also took pictures and videos at an apartment building located at 2735 Rice St, Roseville MN 55113. These photos and videos confirmed a directory listing of Johnson in apartment #103 and the fact there was no light emanating from the apartment. (EX 166 171)
 - 39. On Monday, October 21, 2024, I took video of a residence located

at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I took videos at an apartment building located at 2735 Rice St, Roseville MN 55113. One of these videos shows an attempt to deliver a welcome box of supplies to Curtis Johnson at his listed apartment #103 on the premise that Curtis Johnson is either in the process of moving or soon to move into the apartment.

- 40. After ringing the directory listing for Apartment #103 next to Curtis Johnson's name (which appears as Johnson 103 on the directory), a voice answered the ring. From my presence at the HD40B Forum debate September 17, 2024, replays of his LWV Roseville 623 School Board Candidate Forum October 7, 2021, two podcast appearances on Cities Speak on Nine North I had viewed multiple times, and Curtis Johnson campaign ads I could identify the voice as belonging to Curtis Johnson.
- 41. Curtis Johnson answers the directory button call, which went to his cell phone based on the email sent to me from the Rosedale Estates staff (Ex 250, 259). After Curtis Johnson answers and says "Hello", I say "Hi, Curtis?", and he responds "Yes," which I accepted as his acknowledgment that he was indeed Curtis Johnson. (Ex. 267) I began speaking to my intent to welcome him to HD40B and drop-off a gift box, but Curtis Johnson hangs up the telephone before my delivery attempt can be completed. (EX 172 174)
 - 42. I created a transcript of this audio message to preserve what was

said by Mr. Johnson. (Ex. 267)

- 43. On Tuesday, October 22, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I took videos and photos at an apartment building located at 2735 Rice St, Roseville MN 55113. These photos and videos show a dark apartment #103 with no lighting visible from the exterior at night. Also shown is the door to the apartment with a piece of tape previously placed by another campaign volunteer which shows some dislocation from the door. Additional video and photo is taken at the ISD 623 school board meeting at Anpetu Teca Education Center, 1910 County Rd B W, Roseville MN 55113. This included video of a Blue Mitsubishi Mirage MN license plate FVZ953 in the parking lot and vehicle contents which included campaign signage for Curtis Johnson for State Representative. There is also video taken at the location of a suspected relative of Curtis Johnson in Roseville that reveals nothing. (EX 175 - 185)
- 44. On Wednesday, October 23, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 186, 187)
- 45. On Thursday, October 24, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue

Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I took video and photos at an apartment building located at 2735 Rice St, Roseville MN 55113. These photos and video show the exterior of apartment #103, side access door to the building, and through an approximately 1" crack along the bottom of the apartment #103 door, photos show an empty unfurnished apartment. Also of note is the unique kink in the far end vertical window blind which can be seen both from inside and outside photos of the apartment. (EX 189 - 196)

- 46. On Friday, October 25, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 197, 198)
- 47. On Saturday, October 26, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 200)
- 48. On Sunday, October 27, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 203, 204)
- 49. On Monday, October 28, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue

Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 207)

- 50. On Tuesday, October 29, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I also took a photo and series of videos at an apartment building located at 2735 Rice St, Roseville MN 55113. In these videos and photo are shown once again evidence through a 1" gap under the apartment #103 door of an empty unfurnished apartment. After exiting the apartment building another video shows a blue Mitsubishi Mirage MN license plate FVZ953 parked outside. Prior to lit dropping at the apartment building, I picked up a Rosedale Estates renters info packet at the leasing office after speaking with the assistant property manager. (EX 209 214; Ex. 258)
- 51. On Wednesday, October 30, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. I also took a photo at 11:34am of a blue Mitsubishi Mirage MN license plate FVZ953 parked in the east parking area of 2735 Rice St, Roseville MN 55113 (EX 215 218)
- 52. On Thursday, October 31, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 222)

- 53. On Friday, November 1, 2024, I took videos of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 228, 230, 231)
- 54. On Sunday, November 3, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 236)
- 55. On Monday, November 4, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 240)
- 56. On Thursday, November 7, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 241)
- 57. On Friday, November 8, 2024, I took video of a residence located at 3084 Payne Ave, Little Canada MN 55117 which showed a POD, but no blue Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 242)

Mitsubishi Mirage MN license plate FVZ953 parked in the driveway. (EX 246)
