DENISE KRUSE states:

1. My name is Denise Kruse. I make this affidavit upon personal knowledge of the facts set forth herein.

 I am a resident of 829 Amble Court, Shoreview, Ramsey County, Minnesota.

3. I am a volunteer for the Friends for Paul Wikstrom campaign committee.

4. On Tuesday, September 17, 2024, the evening of the League of Women Voters forum, I took a video of Curtis Johnson leaving a residence at 3084 Payne Ave. Little Canada MN 55117 and getting into a Blue Mitsubishi Mirage MN license plate FVZ953 and pulling out of his driveway. (EX 31)

5. On the afternoon and evening of Wednesday, September 18, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 36-38)

6. On the afternoon and evening of Thursday, September 19, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi

Mirage MN license plate FVZ953. (EX 39-40)

7. On the afternoon and evening of Friday, September 20, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 43-44)

12. On the afternoon and evening of Wednesday, September 25, 2024, I took photos and a video of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 60-62)

13. On the afternoon and evening of Thursday, September 26, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 64-65)

14. On the afternoon and evening of Friday, September 27, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 67-68)

17. On the morning of Monday, September 30, 2024, I took a video and photo of a residence at 3084 Payne Ave. Little Canada, MN 55117 which showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 80-81)

18. Shortly after midnight and in the afternoon of Tuesday, October 1, 2024, I took videos of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 82-87)

19. Shortly after midnight and on the afternoon of Wednesday, October 2, 2024, I took a video of a residence at 3084 Payne Ave. Little Canada, MN 55117 which both showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 90, 91)

20. Shortly after midnight on Thursday, October 3, 2024, I took a video of a residence at 3084 Payne Ave. Little Canada, MN 55117 which showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 93)

21. After midnight on Friday, October 4, 2024, I took a video of a residence at 3084 Payne Ave. Little Canada, MN 55117 which showed 3 vehicles parked in the driveway, to include a Blue Mitsubishi Mirage MN license plate FVZ953. (EX 96)

22. Late evening on Wednesday, October 30, 2024, I took 3 photos of

an apartment building at 2735 Rice Street Roseville, MN 55113. These photos show a dark apartment #103 with no lighting visible from the exterior. (EX 219-221)

23. On Thursday, October 31, 2024, I took a photo of a residence located at 3084 Payne Ave. Little Canada, MN 55117, which showed a POD, 2 cars parked in the driveway, but no Blue Mitsubishi Mirage MN license plate FVZ953. (EX 223)

24. On Thursday, October 31, 2024, I called Xcel Energy to inquire about an account for apartment #103 at 2735 Rice Street Roseville, MN 55113. I was told that there was no account set up for that address. (EX 4)

25. Late morning on Thursday, October 31, 2024, I took a photo of a Blue Mitsubishi Mirage MN license plate FVZ953 parked in front of an apartment building at 2735 Rice Street. (EX 226)

26. On the evening of Thursday, October 31, 2024, I took 2 photos of an apartment building at 2735 Rice Street Roseville, MN 55113. These photos show a dark apartment #103 with no lighting visible from the exterior. (EX 224-225)

27. On the morning of Friday, November 1, 2024, I took a photo of an apartment building at 2735 Rice Street Roseville, MN 55113 with no visible lighting coming from #103. (EX 229)

28. On the morning of Friday, November 1, 2024, I called Xcel Energy

and spoke to Cassandra. She told me that there was no power at apartment #103 at 2735 Rice Street Roseville, MN 55113 and that the unit was listed as a demo and the meter was removed in January 2024. See screenshots of my call log and the feedback text I received after the call. (EX 1, 2, 3)

29. On the morning of Saturday, November 2, 2024, I took a photo of a Blue Mitsubishi Mirage MN license plate FVZ953 parked at Makwa Coffee in Roseville, MN. (EX 232)

30. On the evening of Saturday, November 2, 2024, I took 2 photos of an apartment building at 2735 Rice Street, Roseville, MN 55113. These photos showed a dark apartment #103, with no lighting visible from the exterior. (EX 233-234)

31. On the evening of Saturday, November 2, 2024, I took a photo of a residence at 3084 Payne Ave. Little Canada, MN 55117, which showed a POD, 2 cars parked in the driveway, but no Blue Mitsubishi Mirage MN license plate FVZ953. (EX 235)

32. On the evening of Sunday, November 3, 2024, I took a photo of a residence at 3084 Payne Ave. Little Canada, MN 55117, which showed a POD, 2 cars parked in the driveway, but no Blue Mitsubishi Mirage MN license plate FVZ953. (EX 237)

33. On the evening of Sunday, November 3, 2024, I took 2 photos of an apartment building at 2735 Rice Street Roseville, MN 55113. These photos

showed a dark apartment 103, with no visible lighting from the exterior. (EX 238-239)

34. On the morning of Monday, November 11, 2024, I called Xfinity and spoke with Leonardo inquiring if Xfinity services were hooked up at 2735 Rice Street #103 Roseville, MN 55113. He said the apartment was pre-wired but no active account has been at this apartment since 6/17/23 and that there was a considerable amount of outstanding debt to Xfinity linked to this apartment unit. (EX 261)

35. On the morning of Monday, November 11, 2024, I called Century Link and spoke with Derrick inquiring if services were hooked up at 2735 Rice Street #103 Roseville, MN 55113. He said that there was currently no service hooked up at this address. (EX 262)

36. On November 18, 2024, I downloaded from the Minnesota Secretary of States website a map of Minnesota House District 40B. Ex. 257 is a true and correct copy of that map.

37. On November 18, 2024, I took a screenshot of the Ramsey County property tax summary of 3084 Payne Avenue, Little Canada, Minnesota 55117. The property is owned by Curtis and Jill Johnson. Ex. 270 is a true and correct copy of that summary. Exhibit 249 includes the 2024 and 2025 Property Tax Statements for that address.

38. On November 18, 2024, I downloaded from the candidate filing

webpage from the Minnesota Secretary of State website the summary of candidate Curtis Johnson's Affidavit of Candidacy. Ex. 268 is a true and correct copy of that summary.

39. On November 18, 2024, I took a screenshot of the Minnesota Secretary of State's website indicating that Rosedale Estate, located at 2735 Rice Street, Roseville, Minnesota is located in precinct Roseville P-04 and therefore within Minnesota House District 40B. Ex. 271 is a true and correct copy of that screenshot.

40. On the morning of Thursday, October 31, 2024, I called Xcel Energy. After speaking with a customer service representative, I was given the impression that there was no power hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113. Ex. 4 indicating an 8:04 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

41. On the morning of Thursday, November 1, 2024, I called Xcel Energy. After speaking with customer service representative Cassandra, I was given the impression that there was no power hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113 and that the unit was listed as a demolition apartment and the meter was removed in January 2024. Exs. 1-3 indicating an 8:03 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

42. On November 11, 2024, I called Comcast Xfinity and spoke with Leonardo on the Customer Service Line. I was given the impression that there had been no activity Xfinity internet or cable account at Apartment #103 since June of 2023. Ex. 261 indicating an 9:56 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

43. On November 11, 2024, I called Century Link and spoke with Derrick on their Customer Service line. I was given the impression that Century Link did not have an account or provide service for Apartment #103. Ex. 262 indicating an 10:03 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

44. On the morning of Thursday, November 14, 2024, I called Xcel Energy. After speaking with customer service representative Laura, I was given the impression that there was no power hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113 and that the unit was listed as a demolition apartment and the meter was removed on January 8th, 2024. Further, I was told that the meter was cut at the pole and removed. Ex. 264 indicating an 10:16 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

45. On the morning of Monday, November 18, 2024, I called Xcel Energy. After speaking with customer service representative Sakina, I was given the impression that there was no power hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113 and that the unit was listed as a demolition apartment and the meter was removed in January 2024. Ex. 263 indicating an 8:34 a.m. outgoing call is a true and correct copy of the call log from my iPhone.

46. On the afternoon of Monday, November 18, 2024, I called Comcast Xfinity. After speaking with customer service representative Cynthia, I was given the impression that there was no internet hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113. Ex. 265 indicating an 1:45 p.m. outgoing call is a true and correct copy of the call log from my iPhone.

47. On the afternoon of Monday, November 18, 2024, I called Century Link. After speaking with customer service representative Lariza, I was given the impression that there was no internet hooked up at apartment #103 at 2735 Rice Street Roseville, MN 55113. Ex. 266 indicating an 1:54 p.m. outgoing call is a true and correct copy of the call log from my iPhone.


