

SUPPLEMENTAL DECLARATION OF HARRY NISKA

I, Harry Niska, declare and testify as follows:

1. My name is Harry Niska. I provide this supplemental declaration based on my personal knowledge of the facts set forth herein.

2. On January 30, 2025, in advance of the 3:30 PM floor session, Representative Lisa Demuth emailed Secretary Steve Simon and his staff. Among other information, Representative Demuth informed Secretary Simon that I would be seeking recognition during the 3:30 PM floor session and that it is our belief that as a ceremonial presiding officer Secretary Simon did not have the authority or ability to refuse recognition to duly elected members. A true and correct copy of this email message is attached hereto as Exhibit C.

3. When the House convened at 3:30 PM on January 30, I presented the same motion to compel attendance of absent members and proscribing penalties, as authorized by Article IV, Section 13 of the Minnesota Constitution, which I had offered the previous day, and which was attached as Exhibit B to my previous declaration submitted in this case.

4. A copy of my motion was presented at the front desk, the customary manner for offering written motions.

5. At the conclusion of the quorum call on January 30, I rose seeking recognition to make motions provided by Article IV, Section 13 of the Minnesota Constitution. I stood by the podium at which the Republican caucus leader stands to be recognized to speak regarding points of order, motions, or other matters.

6. Secretary Simon refused to recognize me or acknowledge the motion that I had presented to him. Instead, Simon purported to adjourn the House unilaterally until February 3, 2025, at 3:30 PM without ever allowing motions or vote.

7. On February 3, 2025, the House convened at 3:30 PM, I again presented the same motion to compel attendance of absent members and proscribing penalties, as specifically authorized by Article IV, Section 13 of the Minnesota Constitution.

8. A copy of my motion was presented at the front desk in the same, customary manner for written motions.

9. At the conclusion of the quorum call, I rose seeking recognition to make motions provided by Article IV, Section 13 of the Minnesota Constitution.

10. Secretary Simon, again, refused to recognize me or acknowledge the motion I had presented to him. Instead, Simon purported to unilaterally adjourn the House until February 4, 2025, at 3:30 PM.

11. On February 4, 2025, when the House convened that day at 3:30 PM, I, again, presented the same motion to compel attendance of absent members and proscribing penalties, as specifically authorized by Article IV, Section 13 of the Minnesota Constitution.

12. A copy of my motion was presented at the front desk in the same, customary manner for written motions as I had on previous days.

13. At the conclusion of the quorum call, I rose seeking recognition to make motions provided by Article IV, Section 13 of the Minnesota Constitution.On that day, I verbally requested recognition to make my motion.

14. Secretary Simon refused to recognize me or acknowledge the motion I had presented to him. Instead, Simon purported to unilaterally adjourn the House until February 5, 2025, at 3:30 PM.
