



## Handout - Understanding MCRO Search Results

### Search Results

The Search Results page will display once your search has been successfully submitted. Each search result card will display information to help you locate the case, document, hearing, or money judgment you were looking for. A result card includes the following:

1. A link at the top of the results to the Search screen.
2. The search criteria you entered for your search will be shown. To modify the criteria, use the “Return to Search” link at the top of the results.
3. If your search criteria returned more than one result, all results (up to 200) will be shown. By default, results are displayed Newest First, but you may click Oldest First to reverse the order.
4. A button to Print the list of results will display at the top-right of the results.
