Warrants

If a party on a case has an active warrant, it means that a judicial officer or government official has issued a document (the warrant) authorizing law enforcement to make an arrest, search premises, or carry out some other action relating to the administration of justice. The Warrant flag may apply to the case being viewed or another case. If you see the Active Warrant Flag by a party's name in the Party Information section only, that means that party does not currently have an active warrant on the case but they do have an active warrant on another case(s).

Charges are formal accusations made by a governmental authority (usually a public prosecutor or the police) asserting that somebody has committed a crime. There may be multiple charges within a case. If charges have been amended (meaning that they have been changed), the history of changes will be displayed below the current charges.
