How The Collaborative Effort Began

Aleesha's Action Steps 2016

Wanted to collaborate in community

Called Mesabi Range Campus looking for a connection

Was given Mary Kay's number and reached out

Didn't know what she was doing nut did it anyway

Probably would rethink it now-LOL



On vacation in Jamaica when Aleesha called

Took a shower where she does a great deal of thinking on things

Sparked the idea of participants as students learning about addiction from a counselor perspective with other current students

Everyone participate, Mary Kay's class, treatment court professionals, participants, and distance learners

Pitched to Aleesha

Another shower, another idea: Scholarships



Met and collectively thought we would give it a whirl

Thought out a sketchy plan

1st year introductory addiction courses: Introduction to Addiction and Counseling Theory and Skills (3-hour block classes)

Human Services Helping Process class holds a fundraising event or community event to raise money for scholarships

College Night Philosophy



Using education in rural communities to empower individual change

Creating new and innovative approaches for participant learning that is adaptable to their lifestyle

How to establish community connections in your rural court



Person-centered approach as entering the school environment you are a student and not a "participant"

Learning about being a counselor can enlighten you to the other side as a professional views things

Open communication about substance use disorders and recovery is one key to wellness

Exploring all sides and views can give you a new perspective

Seeing role models succeed can give hope, inspiration, and facilitates identification



Treatment and Hybrid Court Best Practices



Positive contributions of drug courts has been achieving long-term rehabilitation of participants' employment and educational status

Treatment court provides or refers Participants for treatment and social services

Addresses conditions that are likely to interfere with their response to substance abuse or mental health treatment (responsivity needs)

Diminish criminal recidivism (criminogenic needs)

Increase long-term treatment gains (maintenance needs)



Housing assistance Trauma-informed services Criminal-thinking interventions Family or interpersonal counseling **Vocational or educational services** Medical or dental treatment

Participants shall only be required to receive services for which they have an assessed need. – Minnesota Treatment Court Standards (based of NDCI's Adult Drug Court Best Practice Standards, Volume 2)



Community Centered Criminal Justice Learning/Approach-How College Nights Works



<u>Classes</u>

Four times a year, 2 classes in Fall Semester and 2 in Spring Semester (Classes-3 Hour Block Classes)

1st Hour-Treatment Court presents to Mary Kay's cohort, students (participants), and guests

2nd Hour-Everyone networks, food refreshments, and fun

3rd Hour-All Professionals except instructors leave and have engaging lecture/education

Mary Kay's Class signs a waiver for confidentiality



Incentivizing Attendance

\$50 off their Treatment Court Fees or 3 hours CSW credit

FREE FOOD when you attend in person

Unique opportunity for participants to hear from experts in the field

Connect with team members outside of the courthouse and see them from a different perspective

2 Scholarships each year for a free class in either Introduction to Addictions or Counseling Theory and Skills

Covid: A Good Thing?


This is one project that went on uninterrupted during the pandemic


We were already set up with a Zoom Room and capitalized on the situation

2022 DHS GRANT



Grant-Pilot Program

Mesabi Range Campus Addiction Studies Department received \$543,000 to train and empower 30 individuals from the general population with a diagnosis of opioid use disorder

Designed to prepare individuals for successful permit (ADC-T) or certificate (bachelor's degree-LADC)



Grant Project Goals

Provide one year of training in either an Associate of Applied Science degree or Certificate for a person with an established bachelor's degree in Addiction Studies

Provide a \$1600.00 (\$800.00 per semester for 2 semesters) stipend for Fall 2022 semester and Spring 2023 semester

Throughout the grant process assist students with submitting a background check, applying for appeals when needed, and attempt to obtain a set aside if needed for past indiscretions

34 recruited, 30 students currently


27 pursuing AAS Addiction Studies
