

Minnesota Partner Calendar (MPARC) Subscriber Access Overview

This document provides a summary of the Minnesota district court case access government subscribers have to public and confidential cases statewide through Minnesota Partner Calendar (MPARC). The case access is consistent with the access government subscribers received in Minnesota Government Access (MGA). Use this handout to review and understand the access rules for MPARC. Public Cases Access

All government subscribers have access to public district court cases statewide in MPARC. Public cases include, for example:

- Public Adult Criminal and Traffic cases
- Public Juvenile Delinquency +16 cases
- Public Family cases, including public Civil Domestic Abuse and Support cases
- Public Civil cases, including Public Harassment cases
- Public Probate cases and Public Commitment cases
- Public CHIPS cases, post-July 1, 2015

Confidential Cases Access

Some government agencies have access to hearings scheduled on confidential cases in MPARC, based on the Rules of Public Access to Records of the Judicial Branch and Supreme Court orders. The hearings scheduled on confidential cases available in MPARC are explained in the chart following this section.
